² Until **June 2017** all approved audit firms were assessed and classified as **fully acceptable** or **Acceptable for project and grant financial statements only**. **Fully acceptable** audit firms are eligible to audit IFRS based prepared Financial Statements, typically for entity financial statement. Firms that are “Acceptable for project and grant financial statements only” can carry out certain audit assignments, typically only grant and project audits, usually only within their country.

The Revised and Updated Audit Firm Assessment Guidelines (2017) focuses on the acceptability of audit firms to audit of project financial statements. This approach differs from past practice in ECA as the audit firms are no longer approved to be fully or partially acceptable. Therefore, the assessment results do not automatically extend to audit of the entity financial statements. The Guidelines explain in detail in par 7(a) how this matter is dealt, with going forward.
