### **6. Nature of contract**

Unit-price - the lowest price

### **7. Contract description**

The procurement of a “Motor vehicle for the transport of fewer than 10 persons, with a seating capacity of 7+1 and enhanced 4x4 traction with in the Project ROMD00024 (C-TRAINED) Cross border joint training”

### **8. Number and titles of lots**

One lot only

9. Offers are submitted in accordance with the national legal framework on the platform achizitii.md.

## **CONDITIONS OF PARTICIPATION**

### **10. Legal basis**

Project ROMD00024 (C-TRAINED) Cross border joint training, under the Regulation 2021/1059 (Interreg Regulation).

### **11. Number of tenders**

No more than one tender can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting a tender). In the event that a natural or legal person submits more than one tender, all tenders in which that person has participated will be excluded.

The tenderer may submit a tender for one lot only, several lots or all of the lots, but only one tender per lot. Contracts will be awarded lot by lot and each lot will form a separate contract.

Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot.

### **12. Grounds for exclusion**

As part of the tender, tenderers must submit a signed declaration, included in the tender form, to the effect that they are not in any of the exclusion situations listed Project ROMD00024 (C-TRAINED) Cross border joint training.

Tenderer included in the lists of EU restrictive measures ([www.sanctionsmap.eu](http://www.sanctionsmap.eu)) at the moment of the award decision cannot be awarded the contract.

### **13. Sub-contracting**

Subcontracting is allowed.

## **PROVISIONAL TIMETABLE**

14. Submission of bids: by February 20, 2026. Deadline for submitting clarifications: no later than 15 days before the bid submission deadline.

15. Evaluation of bids and determination of the winning bid: by March 19, 2026. Conclusion of the procurement contract: by March 30, 2026.

## **SELECTION AND AWARD CRITERIA**

### **16. Selection criteria**

An economic operator (i.e., candidate or tenderer) may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links it has with them. If the economic operator relies on other entities, it must in that case prove to the contracting authority that it will have at its disposal the resources necessary for the performance of the contract by producing a commitment by those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility as the economic operator relying on them and must comply with the selection criteria for which the economic operator relies on them. Furthermore, the

data for this third entity for the relevant selection criterion should be included in a separate document. Proof of the capacity will also have to be provided when requested by the contracting authority.

With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the tasks for which these capacities are required.

With regard to economic and financial criteria, the entities upon whose capacity the economic operator relies, become jointly and severally liable for the performance of the contract.

The following selection criteria will be applied to the tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole if not specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are sub-contractors.

**1) Economic and financial capacity of the tenderer** (based on item 3 of the tender form). In case of tenderer being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last three financial years for which accounts have been closed.

the selection criteria for each tenderer are as follows:

Criteria for legal and natural persons:

- the lowest price
- the best offer in terms of financial, administrative, and technical aspects
- the financial situation of the tenderer should not be in deficit, taken into account debts, at the beginning and end of year

**2) Professional capacity of the tenderer** (based on items 4 of the tender form).

The reference period which will be taken into account will be the last three years preceding the submission deadline.

**3) Technical capacity of tenderer** (based on items 5 and 6 of the tender form). The reference period which will be taken into account will be the last three years preceding the submission deadline.

#### **17. Award criteria**

The lowest price.

## **TENDERING**

#### **18. Deadline for submission of tenders**

The deadline for submission of tenders is 20 february 2026, 14:00 time.

Clarifications can be submitted no later than 15 days before the bid submission deadline.

#### **19. Tender format and details to be provided**

Tenders must be submitted using the standard tender form.

The tender must be accompanied by a declaration on honour on exclusion and selection criteria (form G3)

Any additional documentation (brochure, letter, etc.) sent with a tender will not be taken into consideration.

## **20. How tenders may be submitted**

Tenders must be submitted in English or national language exclusively to the contracting authority, using the means specified in point 9 of the instructions to tenderers.

Tenders submitted by any other means will not be considered.

By submitting a tender tenderers accept to receive notification of the outcome of the procedure by electronic means.

## **21. Alteration or withdrawal of tenders**

Tenderers may alter or withdraw their tenders by written notification prior to the deadline for submission of tenders. No tender may be altered after this deadline.

Any such notification of alteration or withdrawal shall be prepared and submitted in accordance with point 13 of the instructions to tenderers.

## **22. Operational language**

All written communications for this tender procedure and contract must be in English or national language.

## **23. Additional information**

Financial data to be provided by the candidate in the standard application form must be expressed in EUR or of national currency. If applicable, where a candidate refers to amounts originally expressed in a different currency, the conversion to [EUR] [<ISO code of national currency>] shall be made in accordance with the InforEuro exchange rate of [<MONTH and YEAR> of the applicable InforEuro exchange rate, which can correspond to the month and year of the publication of the present contract notice], which can be found at the following address: <http://ec.europa.eu/budget/graphs/inforeuro.html>.
