4. Co- exhibitors counters

45 pieces of exhibitor stands (exhibitor counters) with a height of 80 cm - made of quality laminate according to the design, with storage space with drawers with handles and lock, with 47 exhibitor logos on the front with LED lighting and on the dividers - Including 47 high chairs for exhibitors. Wooden laminate divider, with 2 shelves for displaying bottles and space for naming at the top. This area will have colored LED lights to create a special atmosphere.

5. Storages

Two wine storage warehouses that will have a storage capacity of 1200 bottles and will have shelves, one for each winery (47 wineries). The storage unit will have clothes hangers for minimum 50-60 people.

According to the design, it will be 6 m high, containing a minimum of 4 WoM logos and a minimum of 4 OIV logos, wine cellar-type shelves for wine storage on 3 sides.

The storage units will be divided into dedicated areas for: differentiated waste, wine storage area, refrigerator area etc.

6. Electricity
