- **Offer price (in MDL, VAT not included)**

a) The minimum price shall be the lowest price out of the offers considered admissible and compliant in technical terms and be given the maximum score, **40 scores (40%)**, respectively

b) The offered price shall be the price of an evaluated offer

Financial proposal score (FP) = (40\*minimum price/offered price)

- **Technical component 1 – Experience of key experts – 40 scores (40%)**

Minimum mandatory requirements: - specific experience of the specialized staff, expressed in number of similar activities, as follows:

- **Pilots** – experience implies the involvement of proposed persons, participation of the latter in activities of aerial distribution of veterinary medicinal products monitored via GPS by handling aircrafts, respectively.

Details regarding the application of scoring algorithm:

- For the participation of specialized staff in the implementation of one (1) project for each of the proposed persons – 0 scores;
- For the participation of specialized staff in the implementation of 2-5 projects for each of the proposed persons – 12 scores;
- For the participation of specialized staff in the implementation of 6-10 projects for each of the proposed persons – 14 scores;
- For the participation of specialized staff in the implementation of over 10 projects for each of the proposed persons – 20 scores.

**Note:** A project means a vaccination campaign, i.e. carrying out activities of the type of aerial distribution of veterinary medicinal products monitored via GPS, by piloting aircrafts addressed to some organization(s)/private beneficiary(ies).

Experience of key experts – if each of the persons proposed as pilots meets the limit of maximum number of projects associated with a timeframe, the economic entity shall be scored according to the evaluation sub-factor.

For example, if 3 out of the 4 pilots proposed have 4 vaccination campaigns as similar experience, and one pilot has 8 vaccination campaigns as similar experience, then the economic entity shall be given 12 scores.

- **Operators** – experience implies involvement of the proposed persons, participation of the latter in activities of aerial distribution of medicinal products monitored via GPS, handling and loading medicinal products in the aircrafts and in the automatic medicinal products distribution devices during the flights, respectively.

Details regarding the application of scoring algorithm:

- For the participation of specialized staff in the implementation of one (1) project for each of the proposed persons – 0 scores;
- For the participation of specialized staff in the implementation of 2-5 projects for each of the proposed persons – 12 scores;
- For the participation of specialized staff in the implementation of 6-10 projects for each of the proposed persons – 14 scores;
- For the participation of specialized staff in the implementation of over 10 projects for each of the proposed persons - 20 scores.

**Note:** A project means a vaccination campaign, i.e. unfolding an activity of the type of aerial distribution of veterinary medicinal products monitored via GPS, handling and loading of veterinary medicinal products in the aircrafts and in the automatic veterinary medicinal products distribution devices during the flights, respectively. Experience of key experts – if each of the persons proposed as operators meets the maximum limit of the number of projects related to a timeframe, the economic entity shall be scored according to the evaluation sub-factor scoring.

For example, if 2 out of the 4 proposed operators have 4 vaccination campaigns as similar experience, while the other 2 operators have 4 vaccination campaigns as similar experiencede, then the economic entity will be attributed 12 scores.

**Evaluation factor scoring 2 = Item 1 (Pilots - 20 scores) + Item 2 (Operators – 20 scores) – Maxim 40 scores (40%)**

- **Technical component 2 – IT Experts – 20 scores (20%)**

The experience of IT expert(s) implies involvement of the proposed person(s), by performing IT activities which include collection and administration of data regarding the distribution of products by air transport and of a server that allows the transmission in real time of geographical data for aerial distribution of products to the Beneficiary, in encrypted form, as well as the possibility to decrypt data based on an algorithm.

Details regarding the application of scoring algorithm:

- For the participation of specialized staff in the implementation of 1 project of the proposed person – 0 scores;
- For the participation of specialized staff in 2-5 projects for each proposed person - 6 scores
- For the participation of specialized staff in the implementation of 6-10 projects for each proposed person - 14 scores
- For the participation of specialized staff in the implementation of over 10 projects for each proposed person - 20 scores

**Note:** A project means a campaign of aerial distribution of products, i.e. performing activities of the type of aerial distribution of products, by collecting and managing the data on product distribution via air transport and a server which allows transmission in real time of the geographical coordinates of aerial distribution of products in encrypted form to the Beneficiary, as well as the possibility to decrypt the data based on an algorithm.

Experience of key experts – if each of the persons proposed as IT experts meet the maximum limit of the number of projects related to a timeframe, the economic entity shall be scored according to the evaluation factor scoring.

**Note:** Technical scoring shall be calculated by adding the scoring of evaluation factors 2 and 3.

Total scoring of FP offer (1) + TP (2+3) = 100

where FP = financial factor scoring (1);

TP = scoring of technical factors (2) and (3).
