Article 1 Subject

- 1.1 The subject of the contract shall be the design, manufacture, delivery, installation of the following supplies:

The place of acceptance of the supplies shall delivered in the case of stickers, roll-up's, notebooks, pens, maps is the Head Quarter of the Beneficiary, billboards will be installed in established by Beneficiary locations of the project, the time limits for delivery shall be end of the project implementation period but no later than 31.12.2022 and the Incoterm applicable shall be [DAP]⁴. The implementation period of tasks shall run from the date of contract signature until to the end of the project implementation period.

- 1.2 The Contractor shall comply strictly with the terms of the Special Conditions and the technical annex including any changes under the proposed variant.
