To whom it may concern

1. ID-1 format polycarbonate cards for various purposes (citizen ID, drivers licences, vehicle registration certificates, etc.);
2. Specialized equipment with system software, designed for the Automated System of production, personalization and issuance of the ID documents;
3. Materials, consumables, spare parts for the specialized equipment in order to provide functioning of the system for issuance of ID-1 format cards on Teslin, ID-1 format cards on polycarbonate, and ID-3 format e-passports with data page on paper/polycarbonate;
4. Specialized software (excluding system software), allowing to exploit the system, pre-installed on specialized equipment, with operating instructions and backup copy on hard storage media.
