**1. OBIECTUL CONTRACTULUI**

Obiectul contractului il constituie asigurarea de catre **Furnizor** a serviciilor de organizare evenimente care vor include, fara a se limita la: designul conceptului, punerea la dispozitie a tuturor echipamentelor, a materialelor, a personalului calificat, a locatiei si a intregii logistici in vederea desfasurarii in cele mai bune conditii a evenimentelor organize in comun (denumite in continuare “Proiect” si/sau “Proiecte”).

**2. VALOREA CONTRACTULUI**

**2.1** Valoarea prezentului Contract este conform anexelor intocmite pentru fiecare Proiect in parte.  
**2.2** Valoarea Contractului se poate modifica in cazul in care Beneficiarul solicita servicii suplimentare sau modificarea caracteristicilor de livrare pentru serviciile cerute anterior. Toate serviciile suplimentarile vor trebui sa fie agreate de ambele Parti.

Mihai Cima in his capacity as Administrator, hereinafter referred to as the “**Provider**”,

And

**VOX SOLUTIONS GLOBAL LIMITED**, with registered office located in Room 2110, 21/F, Wing On Centre 111 Connaught Road Central, Hong Kong, Bank Account 1086282034 opened with CITIBANK N.A. HONG KONG, registered under No. 2485589, duly represented by Stephen Browne, in his capacity as Director, hereinafter referred to as the “**Beneficiary**”.

**1. OBJECT OF THE CONTRACT**

The object of the Contract consists in **Provider** ensuring the **Beneficiary** of event organizing services which will include but will not be limited to: concept design, put at disposal all necessary equipment, materials, qualified personnel, locations and full logistics for organizing in optimal conditions the event (named herein “Project” and/or “Project”).

**2. THE VALUE OF THE CONTRACT**

**2.1** The value of this Agreement is in accordance with the annexes drawn up for each individual project.  
**3.2** The value of the Contract may change if the Beneficiary requests additional services or changes in the delivery characteristics for the services requested above. All supplements will have to be agreed by both parties.

### **3. DURATA CONTRACTULUI**

**3.1** Contractul este valabil pentru o perioada de 2 ani de zile de la data semnarii lui si se poate prelungi numai prin semnarea unui act aditional cu vointa partilor.

**3.2** Expirarea durantei Contractului nu absolve Partile de responsabilitatile si indeplinirea obligatiilor asumate prin prezentul Contract.

### **RESPONSABILITATILE PARTILOR**

#### **4. RESPONSABILITATILE FURNIZORULUI**

**4.1** **Furnizorul** este responsabil pentru livrarea intregului pachet de servicii detaliate in anexe attase corespunzand fiecarui Proiect, conform cerintelor Beneficiarului.

**4.2.** Furnizorul se obliga la indeplinirea tuturor obligatiilor asumate prin prezentul Contract.

#### **5. RESPONSABILITATILE BENEFICIARULUI**

**5.1.** Beneficiarul va pune la dispozitia Furnizorului la cererea acestuia din urma toate informatiile necesare organizarii Proiectelor.

**5.2.** Beneficiarul va oferi sprijinul organizatoric necesar realizarii actiunii.

**5.3.** Beneficiarul isi va respecta obligatiile de plata datorate Furnizorului la termenele stipulate in prezentul Contract si in anexe attase si a eventualelor suplimentari de comanda, agreate in prealabil de catre Beneficiar.

**5.4** In cazul in care in urma desfasurarii Evenimentului, se produc pagube din vina Beneficiarului locatiei inchiriate sau asupra unor facilitati ale complexului inchiriat pentru desfasurarea acestuia, Beneficiarul va achita Furnizorului sumele reclamate de catre proprietarul locatiei care a inchiriat aceste spatii si facilitati Furnizorului ca urmare a evaluarii acestor pagube si pe baza de documente justificative.

#### **6. APROBARI SI AUTORIZARI**

**6.1.** **Furnizorul** garanteaza **Beneficiarului** faptul ca detine autorizatiile si aprobarile necesare pentru prestarea serviciilor asumate pe care le desfasoara in cadrul Evenimentului in locatia stipulata in Contract si anexe attase.

### **3. CONTRACT DURATION**

**3.1** The Agreement is valid for 2 years from the signing date and can be extended only by an addendum signed by both parties.

**3.2** Expiration of the duration of the Contract shall not absolve the Parties of the responsibilities and the fulfillment of the obligations assumed under this Agreement.

### **PARTIES' DUTIES**

#### **4. PROVIDER'S DUTIES**

**4.1** **The Provider** is responsible for delivering the full services pack detailed in the attached Annexes for each Project, as per the Beneficiary's requests.

**4.2** **the Provider** is obliged to fulfill all obligations present in this contract.

#### **5. BENEFICIARY'S DUTIES**

**5.1** Upon **the provider** request, **The Beneficiary** will provide all the necessary information for organizing and delivering the Project(s).

**5.2** **The Beneficiary** will provide organizational support needed in completing the Project(s).

**5.3** **The Beneficiary** will make sure his payments duties are done on time, as per the contract and the annexes together with any previously agreed additional expenses.

**5.4** In the event that following the occurrence of the Event, damage occurs due to the Beneficiary of the rented location or on the facilities of the rented complex for its deployment, the Beneficiary shall pay to the Supplier the sums claimed by the owner of the location who rented these spaces and facilities to the Supplier as a result of the evaluation of these damages and on the basis of supporting documents.

#### **6. APPROVALS AND AUTHORIZATIONS**

**6.1** The Supplier warrants to the Beneficiary that he holds the authorizations and approvals necessary for the performance of the services he undertakes within the Event at the location stipulated in the Contract and its annexes.

## **7. PLATA. MODALITATI DE PLATA. PENALITATI**

**7.1** Plata **Furnizorului** se va face in baza facturilor fiscale emise de catre acesta dupa semnarea de catre Partii a anexelor aferente fiecarui Proiect.

**7.2** Plata pentru fiecare Proiect se va face esalonat, in 2 transe dupa cum urmeaza:

**7.2.1** Prima factura, in valoare de 50% din valoarea Proiectului, conform bugetului specificat in anexele aferente, se va achita in termen de maxim 5 zile de la data primirii acesteia, dar nu mai tarziu de 3 zile inainte de data inceperii evenimentului.

In cazul in care Beneficiarul nu plateste factura de avans inainte de data de incepere a Proiectului stipulata in anexa, Furnizorul va adauga o taxa de 3% din valoarea totala a Proiectului constand in cheltuieli financiare (comision finantare si dobanda credit cat si gestionare resurse financiare). Prin adaugarea aceastei taxe Furnizorul va asigura platile necesare desfasurarii Proiectului in bune conditii.

**7.2.2** In saptamana urmatoare evenimentului, se va elibera a doua factura, in valoare de 50% din valoarea evenimentului plus costurile suplimentare aparute in cazul in care pe durata proiectului apar modificari sau suplimentari din partea Beneficiarului. Aceasta factura va fi achita in termen de 5 zile de la data primirii. Tot atunci va fi eliberata si a doua anexa, ce va include si modificarile sau suplimentarile aparute.

**7.3** In cazul intarzierii la plata a facturilor, Beneficiarul va suporta penalitati de:

- 0,2% din valoarea neachitata pentru fiecare zi de intarziere.

**7.4** Penalitatatile de intarziere nu vor putea depasi valoarea serviciilor si sumelor ramase neachitate.

## **7. PAYMENT. PAYMENT CONDITIONS. PENALTIES**

**7.1** The payment will be made based on the invoices issued after every annex is agreed and signed.

**7.2** The payment for each Project will be settled in 2 installments as follows:

**7.2.1** The first invoice in total value of 50% from the overall budget as per the annexes, will be paid in 5 days after the invoice is received but no later than 3 days before the event.

If the beneficiary doesn't pay the advance invoice before the start date of the Project mentioned in the annex, the Supplier will add a 3% tax of the total value of the project. This tax represents the commission that the Supplier is paying for accessing a credit line, the interests for that credit line and other financial handling expenses. By adding this tax, the Supplier will make the necessary payments for the Project to be delivered as agreed with the Beneficiary.

**7.2.2** In the week following the Event, the 2nd invoice will be issued, representing the remaining 50% of the initial total amount plus all supplementary costs (if there are any), together with the 2nd annex. The invoice shall be paid within 5 days after the receiving date.

**7.3** In case of any payment delays, the Beneficiary will receive the following penalties:

- 0.2% of the unpaid value for each day of delay.

**7.4** Late penalties may not exceed the value of the services and unpaid amounts.

## **8. RASPUNDEREA CONTRACTUALA**

**8.1** În cazul în care Organizatorul Evenimentului nu își va respecta obligațiile contractuale, Beneficiarul va avea dreptul de a factura toate daunele directe dovedite.

## **8. LIABILITY**

**8.1** If the Event Organizer will fail to comply with his contractual obligations, the Beneficiary will be entitled to invoice all proved direct damages.

**8.2** If the Beneficiary makes a claim for indirect damages, the Parties will work together to establish

## **9. FORTA MAJORA**

**9.3** Prin Forta Majora se inteleag toate evenimentele si/sau imprejurarile independente de vointa Partii care o invoca, imprevizibile si de neinlaturat si care, survenind incheierii Contractului, impiedica sau intarzie, total sau parcial, indeplinirea obligatiilor izvorand din acesta.

**9.4** Aceste evenimente includ, dar nu se limiteaza la razboi, revolutii, miscari sociale, sau catastrofe naturale, care ar putea obstructiona fiecare dintre Partile contractante in indeplinirea obligatiilor ce ii revin.

## **9. FORCE MAJEURE**

**9.1** Force Majeure defends the Party invoking it, but only to the extent and for the period when the Party is prevented or delayed to execute its obligation due to the Force Majeure situation. Each Party shall take all due diligence to reduce as far as possible the effects resulting from Major Force.

**9.2** The Party invoking Force Majeure must notify the other Party within 5 calendar days of its appearance.

**9.3** Force Majeure means all events and / or circumstances that are independent of the will of the Party to invoke, unforeseeable and unenforceable, and which, occurring in the termination of the Contract, impedes or is delaying, totally or partially, the fulfillment of the obligations arising therefrom.

**9.4** These events include, but are not limited to, wars, revolutions, social movements, major changes in legislation or natural disasters, which could obstruct each of the Contracting Parties in meeting their obligations.

## **10. INCETAREA CONTRACTULUI**

**10.1** Prezentul contract inceteaza la termenul stipulat in art. 3

**10.2** Prezentul contract poate inceta mai devreme de termenul mentionat la art.2 fara indeplinirea vreunei formalitati prealabile si fara interventia unei instante judicatoaresti, in urmatoarele situatii:

**10.3** Rezilierea contractului nu va avea nici un efect asupra obligatiilor deja scadente intre Partile contractante. Prevederea anterioara nu inlatura raspunderea Partii care in mod culpabil a cauzat rezilierea Contractului.

**10.4** Denuntarea unilateralala a prevederilor prezentului contract este posibila si permisa numai in conditiile transmiterii catre cealalta Parte a unui preaviz cu cel putin 30 de zile inainte de data

## **10. CONTRACT CANCELLATION**

**10.1** This Contract shall terminate within the term stipulated in Art. 3

**10.2** This contract may terminate earlier than the term referred to in Article 3 without any prior formalities and without the intervention of a court in the following situations:

- when a Party is declared in default of payment, bankrupt or the winding-up procedure of the company is declared.
- when a Party assigns the rights and obligations arising from this Agreement without the written consent of the other Party.

**10.3** Termination of the contract will have no effect on obligations already due between the Contracting Parties. The foregoing provision does not remove the liability of the Party that guiltily caused the termination of the Contract.

**10.4** Unilateral denunciation of the provisions of this Agreement is only possible and permitted only if the notice is given to the other Party at least 30 days prior to the requested date for the termination of the

In the event that the Beneficiary decides to terminate this Agreement which entails the cancellation of a Project and for that Project, the Supplier has begun its preparation, the Beneficiary owes the Supplier to cover the expenses incurred by the Supplier until the moment the Project is canceled on the basis of justifiable documentation of those expenses, and a cancellation fee equivalent to 30% of the Agency's commission as stated in the Project Attachment.

## **11. APPLICABLE LAW AND SETTLEMENT OF LITIGATIONS**

This Agreement is consistent with and under the rule of Roman law. Any dispute between the Parties, which can not be settled amicably, will be referred to the competent Romanian joint law courts.

## **12. MODIFICATION OF THE CONTRACT**

This Agreement may be amended only by an additional act signed by both Parties.

## **13. FINAL PROVISIONS**

**13.1** This Agreement is also binding on and for the benefit of the Contracting Parties, their successors or their representatives, provided that none of the Parties will transfer this Agreement or any of its rights and / or obligations under this Agreement except with the written consent of the other Party.
