What is a C-SKU?

Original HP contractual toner cartridges ("C-SKUs") are original HP products that guarantee the same genuine high quality and reliability as traditional Original HP LaserJet toner cartridges. They are exclusive to end customers under Supplies Big Deal (SBD) or Managed Print Services (MPS) contract.

HP provides selected toner cartridges in differentiated plain white packaging (see below) with product numbers ending in: -AC, -XC, or -YC. The suffix -C stands for "contractual."



Where can I find them?

Original HP contractual toner cartridges are only available within the SBD or MPS Programs through our top strategic SBD or MPS Supplies partners.
