### Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The hardware on the garments was tested to Clause 6.1 of EN 469:2005 (Flame Spread), but with the method modified by the procedure detailed in the Co-ordination of Notified Bodies 'Recommendation For Use' sheet No. 21-013, approved by Vertical Group 5 on 09/05/2006. The recommended method is to apply the flame to the outer surface of the region of clothing containing the hardware, if that hardware is concealed from flame in use, rather than to apply the flame directly to the hardware, as specified in EN 469.
- The Hook and Loop on the garments was tested in accordance with Clause 6.1 Flame Spread and found to fail the requirements, due to the inability of the closure to function after the test. EN 469:2014 requires the closure only need be able to open once after testing. In the opinion of BTTG Testing & Certification, this is the latest interpretation of this particular test requirement, and on this basis we deem it acceptable for the certification.

### Observations

- The assemblies at the cuffs and hem of the Fire Fighter Coats and hem of the Fire Fighter Trousers included anti-wicking fabrics in place of the thermal layer, and as required by Clause 4.6 of EN 469:2005 (Anti-wicking barrier) these assemblies were tested to Clauses 6.1 (Flame Spread), 6.2 and 6.3 (Heat transfer – Flame and Radiation). The assemblies met the requirements of Clause 6.1, and were classified as Level 2 according to Clauses 6.2 and 6.3.
- The Fire Jacket together with Fire Trousers meet the requirements of Annex B.1 and Annex B.2 of EN 469:2005 (Visibility) for area of retroreflective and fluorescent material, as required by Clause 6.14 of EN 469.
