Authorized Body has found out that the production control system performed by the importer conforms to the relevant technical documentation and ensures that the products placed on the market meet the requirements established at the above mentioned technical regulations and the Building Technical Approval and conform to the technical documentation according to §4, clause 3.

Protocol No. 227-P5-09-0128 of 3th April 2009 as amended No. 227-P5-09-0128/1 of 1st April 2018 which involves the results of the findings, verification and the test results, fundamental description of the certified products necessary for their identification, is an integral part of this certificate.

Authorized Body 227 carries out at least once a year a surveillance on the proper operation of the checking production control system performed by the importer, takes product samples, performs their tests and reviews if the product characteristics conform with technical regulations and the Building Technical Approval determined standards according to the provision of §5, clause 4 of the above mentioned Government Regulation. In case that the Authorized Body finds faults, it is empowered to withdraw or to change the certificate.
