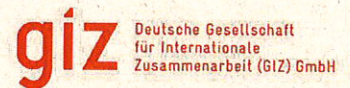

Preamble

WHEREAS, UNHCR wishes to retain the Contractor to provide Translation and Interpretation services on a "non-exclusive basis" in accordance with the terms and conditions set forth in this Frame Agreement;

WHEREAS, the Contractor represents that it is qualified, ready, able and willing, and possesses the necessary expertise, qualified personnel, facilities, equipment, tools, insurance and other means, to provide these services in accordance with the terms and conditions set forth in this Frame Agreement;

NOW, THEREFORE, in consideration of the mutual promises and subject to the terms and conditions contained herein, UNHCR and the Contractor (collectively referred to as the "Parties" and each individually as a "Party") agree as follows:

Article 1 – Purpose of this Frame Agreement.

1.1 The purpose of this Frame Agreement is for the Contractor to provide Translation and Interpretation services (the "Services") to UNHCR, in accordance with the terms and conditions specified herein, as fully outlined in Annex B, and on the basis of firm rates agreed among the Parties as specified in Annex C hereto. The Contractor agrees not to increase the rates for the entire duration of this Frame Agreement.

1.2 This Frame Agreement does not constitute an agreement for the provision of any or all of the Services. Only an order in the form of a purchase order as provided in Article 6 below shall oblige UNHCR to pay for the Services identified in such purchase order.

1.3 The Parties acknowledge and agree that nothing in this Frame Agreement commits, nor shall be construed as committing, UNHCR to deal with the Contractor as a sole or first preferred source supplier of the Services. This Frame Agreement is on a non-exclusive basis and UNHCR may order or have ordered the services set forth herein from any other source whenever
