5. In order to protect IAI's rights, the Customer shall ensure that the Software and the accompanying Documentation are treated in strict confidence.
6. If IAI has manufactured and delivered Products according to drawings, models, samples or other documents submitted by the Customer, the Customer shall warrant that such drawings, models, samples and other documents do not infringe the intellectual property rights and copyrights of any third parties and shall indemnify and hold the Supplier harmless from any claims of third parties on such account.
7. The Customer shall not be allowed to introduce changes to the Products, unless the nature of the delivered Products dictates otherwise or if agreed upon otherwise in writing between the Parties.
