#### Indication and destination of use

A phenylalanine free foods indicated for use in the dietary management of Phenylketonuria in people from 3 years old and older.

**Ingredient list:** L-lysine-L-aspartate, L-leucine, L-tyrosine, glycine, stabilizer: sodium alginate, hydroxypropyl methylcellulose; L-arginine-L-aspartate, L-valine, L- glutamine, L-proline, L-isoleucine, L-threonine, anticaking agent: magnesium salt of fatty acids; L-serine, coating agent: hydroxypropyl-methylcellulose, isomalt, calcium carbonate, medium chain triglycerides; L-histidine, L-alanine, L-cystine, L-tryptophan, L-methionine, L-arginine, L-carnitine L-tartrate, L-taurine, dye: iron oxide and hydroxide.

**Direction of use**: the daily dose must be determined by the clinician or dietitian depending on the age, body weight and clinical condition of the patient. Use the measuring cup included in the box to dose the product. Indicatively we recommend to take14g of microtabs per day, one measuring cup filled up to 20ml with microtabs (corresponding to 10g ca. of equivalent proteins), with water or other permitted liquid (including custard, jam or fruit puree). The coated microtabs have yellow color, no taste and no smell: do not chew, solubilize or pulverizing to avoid lose this characteristic.
