

Medical Food/Food for Special Medical Purposes (FSMP) For the dietary management of Phenylketonuria (PKU)



Dosage and Administration

Dosage to be determined by the clinician or dietitian and is dependent on the age, body weight and medical condition of the patient.

PKU Easy Microtabs are small, coated tablets which are to be swallowed whole with liquid.

Can also be taken together with cold foods, such as applesauce, jam or phe-free pudding. Due to the coating, PKU Easy Microtabs should not be chewed or crushed and have minimal smell and taste.

The measuring cup included inside the box should be used to measure the microtabs. Please fill the cup with microtabs up to the 20 ml mark. This will equate to 14 g of microtabs.

14 grams of microtabs = 10 grams of protein equivalent.

Important Notice:

Must only be given to patients with proven PKU under strict medical supervision.
Suitable from 3 years of age.
Not for use as a sole source of nutrition.
Diet must be supplemented with natural protein, water and other nutrients in prescribed quantities to supply phenylalanine, fluid and general nutritional requirements.
For enteral use only. Not for parenteral use.

Storage:

Store in a cool, dry place.
Once opened, the product should be consumed within one month
