

# Contract Agreement

**THIS CONTRACT AGREEMENT is made on the 24 day of September, 2020.**

**BETWEEN**

- (1) **City Hall of Chisinau, Republic of Moldova, and having its principal place of business at 83 Stefan cel Mare blvd., Chisinau MD-2012, Republic of Moldova (hereinafter called "the Employer"), and**
- (2) **Joint Venture of**
- (i) **Techno Test SRL, a corporation incorporated under the laws of Republic of Moldova under reg. No. 1003600030906 and having its principal place of business at 66 M. Eminescu str., Chisinau MD-2012, Republic of Moldova (Lead Partner)**
  - (ii) **Profaluminu SRL, a corporation incorporated under the laws of Republic of Moldova and having its principal place of business at 17 G. Vieru str., Chisinau, Republic of Moldova (Partner)**
  - (iii) **Promintergaz SRL, a corporation incorporated under the laws of Republic of Moldova and having its principal place of business at 19 Dacia blvd., Chisinau, Republic of Moldova (Partner)**
  - (iv) **Torconst SRL, a corporation incorporated under the laws of Republic of Moldova and having its principal place of business at 90 Uzinelor str., Chisinau, Republic of Moldova (Partner)**

**all together hereinafter called "the Contractor".**

**WHEREAS the Employer invited tenders for the execution of the Works, described as Energy Efficiency Measures in 6 kindergartens and has accepted a Tender by the Contractor for the execution and completion of these Works and the remedying of any defects therein, and the Employer agrees to pay the Contractor the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.**

**The Employer and the Contractor agree as follows:**

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract documents referred to.**
- 2. The following documents, in order of precedence, shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.**
  - (a) **the Letter of Acceptance**
  - (b) **the Letter of Tender**
  - (c) **the Addenda No's 2 dated 2<sup>nd</sup> September 2020**
  - (d) **the Particular Conditions**
  - (e) **the General Conditions**
  - (f) **the Specification**
  - (g) **the Drawings; and**
  - (h) **the completed Schedules and any other documents forming part of the Contract**
- 3. In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to execute the Works and to remedy defects therein in conformity in all respects with the provisions of the Contract.**
