- (b) having been notified of the acceptance of its Bid by the Contracting Authority during the period of bid validity, fails or refuses to sign the Contract Agreement.

This guarantee will expire:

- (a) if the Bidder is the successful Bidder, upon our receipt of copies of the contract signed by the Bidder; or
- (b) if the Bidder is not the successful Bidder, upon the earlier of
 - (i) our receipt of a copy of your notification to the Bidder of the name of the successful Bidder; or
 - (ii) fifty days after the expiration of the Bidder's Bid; or
- (c) in any case not later than 28.09.2022

Consequently, any demand for payment under this guarantee must be received by us, at our office above attn. CSPC/SARMC on or before that date.

The law applicable to this guarantee shall be that of the Republic of Moldova. Any dispute arising out of or in connection with this guarantee shall be referred to the courts of the Republic of Moldova.

The guarantee will enter into force and take effect from the submission deadline of the tender.
