Your signatures on the Demand must be verified by your bank as authentic and legally binding on the Beneficiary.

The Guaranteed Amount shall be decreased by every payment from this guarantee made by us. This guarantee shall terminate after the whole Guaranteed Amount has been paid out.

This guarantee is effective until **31 December 2025** inclusive (the “**Expiry date**”). This guarantee expires by lapse of the Expiry date regardless whether the Expiry date is a business day or not at the place for presentation of the Demand.



Prior to the Expiry date this guarantee shall also terminate by lapse of the day on which we receive your written notification stating that we are released from all liabilities under this guarantee and you have no claims against us related to this guarantee. This notification must be presented to us in the same form as for the Demand (including signatures verification).


This guarantee is not transferable. Proceeds ensuing from this guarantee cannot be assigned or pledged.

This guarantee is subject to the Uniform Rules for Demand Guarantees (URDG) 2010 Revision, International Chamber of Commerce Publication No. 758.


