
To whom it may concern,

This letter is to request a name change for our **Exempt Distribution License 20-23904-01E** (Attachment – Item 1) and **Sealed Source and Device Registration Certificate NR-0399-D-101-E** (Attachment – Item 2) that are currently issued to Morpho Detection, LLC. We would like to withdraw the amendment request dated April 30, 2017 (Attachment – Item 3) and resubmit this new application. The new name "**Rapiscan Systems, Inc.**" was effective on July 7, 2017. The following is a brief description of the corporative change of ownership since April 6, 2017.

- Prior to April 6, 2017, Morpho Detection was part of Safran Identity & Security.
- On April 6, 2017, Smiths Group plc. completed the acquisition of Morpho Detection that was conditional on the post-completion divestment of Morpho Detection's explosive trace detection business (ETD).
- On July 7, 2017, OSI Systems, Inc. completed the acquisition of the former Morpho Detection's ETD business from Smiths Group plc. The ETD business was merged with and into the Rapiscan Systems, Inc.
 - **Rapiscan Systems**, an OSI Systems company, is headquartered in Torrance, California.
 - **OSI Systems, Inc.** is a vertically integrated designer and manufacturer of specialized electronic systems and components for critical applications in the homeland security, healthcare, defense and aerospace industries.

The following chart is the company organization chart after the merger on July 7, 2017.





Post-merger, the former Morpho Detection's ETD business was fully integrated into Rapiscan Systems, Inc. The legal documentation of the merger is attached (Attachment – Item 4).

For our **Exempt Distribution License 20-23904-01E** (Attachment – Item 1), we would like to make changes to the license condition 12.A:

12. A. The licensee may distribute only from its facilities located at 7151 Gateway Boulevard, Newark, California; and 23 Frontage Road, Andover, Massachusetts.

Please remove the Newark, CA facility from license condition 12.A. The Newark facility is now part of Smiths Detection. The Andover facility is now part of Rapiscan Systems. The device models listed on our Exempt Distribution License 20-23904-01E (Attachment – Item 1) and Sealed Source and Device Registration Certificate NR-0399-D-101-E (Attachment – Item 2) are being manufactured at Rapiscan Systems, Inc., located at 23 Frontage Road, Andover, Massachusetts.

No change was made to the products since the last amendment to NR-0399-D-101-E on June 11, 2015.

No change was made to the previous commitments made by the former Morpho Detection, LLC.
