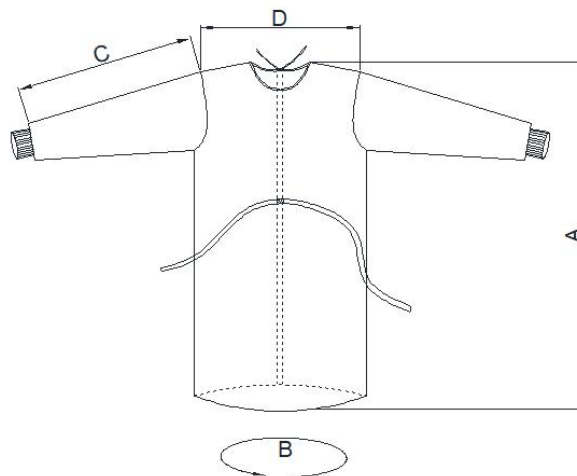

- **Product Name:** Sterilized Isolation Gown

- **Description:** Isolation gown is made of high quality SMS+PE, with velcros at neck. White knitted cuffs are used.
- **Intended use:** Used to isolate the dust and bacteria, prevent the scurf and hair falling.
- **Material:** SMS+PE (minimum 3 layers SMS non-woven material, resistant to liquid penetration within 50-80 H₂ O according to EN 20811:1981 test (European certification body test method)).

Reinforced at the front: polypropylene and/or polyethylene film, minimum thickness 15 g/m², length from shoulders to hem at least 75 cm.

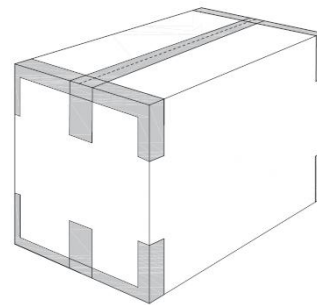
Gown must comply with EN 13795 standard or equivalent; sewing with laser (ultrasound sewing also accepted).

● Packaging:

(1) Carton Requirements: Five layers corrugated

(2) Packing Quantity: 1pc/pouch, 50pcs/ctn

●Storage:

(1) Store in dry, clean conditions in original packaging.

(2) Store away from direct sunlight, source of high temperature and solvent vapors.

(3) Store with the temperature range -5°C to +45°C and with relative humidity below 65%.

●Shelf Life:

Shelf life is 36 months from the date of manufacture when stored as stated above.

●Cautions and disposal:

(1) Do not contact with heavy oils, sparks or flames;

(2) Do not use in the environment with conditions of excessive heat;

(3) Replace if damaged, heavily contaminated or in accordance with local practice;
