**Title:** Evaluation of offers for the purchase of an early warning system.

**Estimated Service Value:** €10,000

**Estimated Project Value:** €7,000,000

Contract Duration: October 2022 - December 2022

**Project Description:** Provision of consulting services for the tender execution process but mainly for the technical evaluation of the five received offers. Participation in evaluation committee sessions, documentation of technical evaluation, and provision of consulting services to the evaluation committee.

**Title:** Consulting services for risk assessment, business continuity plan, and recovery plan.

**Estimated Service Value:** €10,000

Estimated Project Value: N/A

Contract Duration: January 2022 - February 2022
