

THE STANDARD FORM OF THE SINGLE DOCUMENT OF EUROPEAN PURCHASES

- 1. The single European procurement document (hereinafter, DUAE) is a declaration on its own responsibility, through which the economic operator confirms the fulfillment of the qualification and selection criteria required in the public procurement procedures in the Republic of Moldova.
- 2. The form is filled in, signed electronically and sent to the contracting authority when the offer is submitted.
- **3.** A DUAE submitted by the economic operator in the framework of a previous public procurement procedure can be reused, provided that the information contained in the form is correct and valid on the date of its submission.
- **4.** The tenderer who presents false information in the DUAE or the supporting documents presented do not confirm the information indicated in the presented document is excluded from the public procurement procedure and/or may respond according to the law.
- **5.** The DUAE form consists of 7 chapters, namely:
- 1) Chapter I. Information regarding the public procurement procedure and the contracting authority/entity;
 - 2) Chapter II. Information about the economic operator;
 - 3) Chapter III. Reasons for exclusion from the public procurement procedure;
 - 4) Chapter IV. Criteria for qualification and selection of economic operators;
 - 5) Chapter V. General indications for the selection criteria of economic operators;
 - 6) Chapter VI. Pre-selection of candidates for the public procurement contract award procedure;
 - 7) Chapter VII. Final statements.
- **6.** Submission of the DUAE form upon submission of the bid that does not comply with the requirements set forth in the Award Documentation will result in the rejection of the bid.
