# Easy Patient Transportation

Handling heavy equipment can increase risk of injury to caregivers. Sprint 100 is easy to push and operate due to its user-centric design.



### Side Bumpers

Uniquely designed side bumpers protect the stretcher from damage during transportation.



A low push force, 5th wheel steering and an integrated shock absorption make patient transport smooth and comfortable.



#### **IV&Drive**

Sprint 100 is the world's first stretcher with IV poles designed as push handles.

Standard IV poles are prone to breaking when used for pushing. With LINET's IV&Drive technology, IV poles can safely absorb the working load of 100 kg / 220 lb without bending.<sup>6</sup>



### EasyBrake

With EasyBrake, releasing or activating the brakes by pushing the foot lever down instead of pulling up, minimizes physical restraint and supports ergonomic working.

EasyBrake eliminates the need to move to the sides of the bed when using the brake with the head and foot location of the brakes.



### FlexiDrive

To improve patient comfort the Sprint 100 utilizes a retractable 5th wheel that utilizes a shock absorber to reduce the shock from obstacles and uneven surfaces.

# Patient's Safety and Comfort

Patient safety and comfort are part of the Sprint 100's design from its advanced mattress choice to SoftDrop siderails.





### SoftDrop Siderails

SoftDrop siderails cover most of the stretcher's length. They can be easily released whenever needed from both sides of the stretcher. Furthermore, thanks to the SoftDrop feature, siderails are lowered smoothly, gently and silently, resulting in a minimal risk of hand entrapment.



#### Increased Comfort

The right choice of mattress can improve the overall experience of the patient. Sprint 100 offers three mattress options to address various needs of hospitals\*.

Sprint 100's Advanced Mattress offers memory foam and Thermic layer.

# Support Patient's Recovery

When in critical condition, the patient can face multiple breathing related or cardiac difficulties. With easy controls, Sprint 100 can be adjusted to positions that improve the patient's vital functions.



#### Cardiac Chair Position

The Cardiac chair position improves the patient's breathing and cardiovascular functions. While staying on the stretcher it is vital to make the patient comfortable.

With hydraulic foot controls, it is easy to put the patient into the right position. Many treatments are easier in the sitting position, including administration of medications.



Vascular Leg Position

Sprint 100 can be put into Vascular leg position.



### **Angle Indicator**

The integrated Angle Indicator allows easy reading of the backrest angle. Its position allows for easy monitoring of the mattress platform incline.

Sprint 100 has both Trendelenburg and Anti-Trendelenburg position.












#### To lift Mattress Support Platform:

▶ press Lifting pedal and repeat it until intended position is reached

#### To perform bleeding procedure of hydraulic units:

▶ press Lifting pedal 10 times in the highest bed position


