#### We, the signatories:

- ii. Execute and deliver any other documents forming part of the Tender or otherwise reasonably required to be delivered by the National Bank of Moldova in connection with the Tender; and
- iii. Act as the agent and representative of the association with respect to any and all dealings with the National Bank of Moldova in respect of the award of a Contract for the Project.

The Members of the Association will be jointly and severally liable to the Beneficiary for the implementation of the Project, for the actions, inactions of the Leader or of each of the Members

of the Association in relation to the covenants made in the Tender, and in any Contract that may be awarded to the Association as a result of the Tender.

The leader shall ensure the management and implementation of the project in accordance with the contract provisions, local legislation and in accordance with the National Bank of Moldova instructions, with maxim professionalism, efficiency and applying the best practices in the field.
