*RE: Chisinau International Airport Legal Liability/ Tender 2026*

Dear Sir/Madam,

We, UlysseRe Limited, hereby confirm that if Insurance Company Moldasig is appointed as sole and exclusive Insurer by Chisinau International Airport following the Airport Owners and Operators and Contractors Legal Liability tender results in 2026, we are ready to assist Moldasig Insurance Company with the reinsurance of the aforesaid risk based on the terms and conditions below:

**Line of business to be reinsured:** Airport Owners and Operators and Contractors Legal Liability

**Period:** 12 months from 09 August 2026 or the date to be advised

**Combined single limit:** bodily injury, property damage and personal injury USD 100,000,000 any one accident/ occurrence and/ or as original.

**Wordings:** As Original (but no wider than Ariel Major Airport Wording AVN 104) and subject to the following:

Reinsurance Underwriting and Claims Control Clause AVN 41A (excluding Rate and Retention):

1. This Policy is a reinsurance of the Reinsured, and it is warranted to be at the same terms and conditions as those applying to the Reinsured(s) as agreed at inception.
2. Subject to the foregoing, it is a condition precedent to any liability under this Reinsurance that:
  - a) no amendment to the terms or conditions of, or additions to or deletions from the original policy shall be binding upon the Reinsurers unless prior agreement has been obtained from the said Reinsurers;
  - b) the Reinsured(s) shall upon knowledge of any loss or losses which may give rise to a claim under this Reinsurance, advise the Reinsurers within 72 hours;
  - c) the Reinsured(s) shall furnish the Reinsurers with all information available respecting such loss or losses, and the Reinsurers shall have the sole right to appoint adjusters, assessors, surveyors and/or lawyers and to control all negotiations, adjustments and settlements in connection with such loss or losses.

Pursuant to the foregoing Reinsurance clause, except as may be provided for herein, this Reinsurance follows the Original Policy issued by the Reinsured to the Original Insured specifically in respect of which this risk is a Reinsurance.

Simultaneous Settlements Clause (Reinsurance) LPO438.

Reinsurance cancellation clause AVN 112 paragraph (b) amended to 30 days

**Reinsurer:** Allianz Global Corporate & Specialty SE (rating S&P AA)


**Reinsurer's share:** up to 100% of Limit

Final terms and conditions of the reinsurance cover will be subject to the final underwriting information provided to us and approved by the reinsurer. No cover given at this point.
