Manufacturer's Authorization

WHEREAS:

Delivery and hand over of the special purpose vehicles to the Contracting Authority in Republic of Moldova will be under the full responsibility of **SRL "Autoritate Grup"**.

* By providing this authorization, **ARTHOR Otomotiv ve Güç Sistemleri A.Ş.** will be responsible only against the company **SRL "Autoritate Grup"** to provide required special purpose vehicles (blood donation van) in the tender, in accordance with the compliance document and proforma invoice we provided for them. **SRL "Autoritate Grup"** will be fully responsible only against the contracting authority, for the final delivery of the special purpose vehicles.

Warranty Clause:

We will keep our warranty for ONLY conversion works we applied on the special purpose vehicles (blood donation van) as an integral unit of 24 months or 200,000 km, whichever comes first.

The warranty of the base vehicle which will be provided, according to the eventual public procurement contract for a minimum period of 24 months or 200.000 km being the full responsibility of the **SRL "Autoritate Grup"**.

We declare that the supplies used for the special purpose vehicles conversion (blood donation van) will be new, unused, of the most recent models and incorporate all recent improvements in design and materials, unless otherwise provided in the contract.

We further declare that all supplies will have no defects arising from design, materials, or workmanship, except insofar as the design or materials are required by the specifications.

We will be responsible to making good any defect in, or damage to, any part of supplies used for special purpose vehicles conversion which may appear or occur during the warranty period,

and which results from the use of defective materials, faulty workmanship, or design of the manufacturer. Any defects arising from user or operation faults, or natural tear down will not be covered. Manufacturer's warranty terms and conditions may apply for the devices and equipment, which are supplied in the special purpose vehicles, being ensured through SRL Autoritate Grup.

Corresponding confirmation with the technical specifications requested by the contracting authority of the delivered goods (special purpose vehicles + equipment) is proven by Technical Specifications specified in the annex, which is an integral part of this document.

This Certificate of Authorization is issued and signed under the condition that it will be valid until 31.12.2026. (Warranty for conversion will be valid 24 months or 200.000 km)
