TECHNICAL SPECIFICATIONS: TRAFFIC MONITORING CENTER VIDEO WALL

General Description:

The primary objective of this tender is to request proposals for the supply and installation of a highquality Video Wall system for the Traffic Monitoring Center (TMC) located in Chişinău, Moldova. The Video Wall will serve as a critical component for real-time monitoring and visualization of traffic conditions, road situations and public transport operations throughout the city. Its purpose is to substantially enhance the city's ability to make real-time decisions, manage traffic efficiently and respond promptly to various transportation issues.

Scope of Work:

- **Supplies**: Furnishing a Video Wall system that complies with or exceeds the technical specifications detailed in the tender documents.
- **Installation**: End-to-end installation of the Video Wall system, including all necessary hardware components, within the control room of the TMC.
- Configuration: Initial setup and configuration of the Video Wall system.

Additional Requirements:

- 1. The supplier(s) must provide their registration number from the list of producers in accordance with p. 111 of the Regulation on waste electrical and electronic equipment, approved by Government Decision no. 212/2018.
- 2. The supplier(s) must provide documentary evidence of the availability of a service center for the proposed equipment on the territory of the Republic of Moldova.
- 3. All equipment specified in the tender must be brand new and not refurbished/renewed.
- 4. Video Wall panels must be under warranty and supported by the manufacturer for at least 36 months. The proposal should include Manufacturer's Declaration that certifies the product(s) in question are not End-of-Life (EoL) products and are expected to receive updates and support for at least 36 months. Any products that are considered End-of-Life products would not be accepted.
- 5. "CE" declarations of conformity ("Conformité Européenne").
- 6. Manufacturer's ISO 9001 quality management system certificate.
- 7. The Video Wall equipment should not be vendor-locked and should enable seamless scalability for future expansion or integration with emerging technologies.
- 8. The updates of the software related to the Video Wall (if any) should be free of charge.

The Video Wall will be installed at the Chisinau Traffic Monitoring Center building – located: Republic of Moldova, mun. Chisinau, 18 Serghei Lazo street – the office of General Directorate of Urban Mobility.
