Cutlery of the collection "BASE" from the brand WMF, consisting of different spoons (12.23xx.6040) and forks (12.23xx.6040) made of Cromargan stainless steel 18/10 as well as different Monobloc knives (12.23xx.6049) made of blade steel.

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2024 – 2nd Edition).
