Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The hardware on the garment was tested to Clause 6.1 of EN 469:2005 (Flame Spread), but with the method modified by the procedure detailed in the Co-ordination of Notified Bodies 'Recommendation For Use' sheet No. 21-013, approved by Vertical Group 5 on 09/05/2006. The recommended method is to apply the flame to the outer surface of the region of clothing containing the hardware, if that hardware is concealed from flame in use, rather than to apply the flame directly to the hardware, as specified in EN 469. Using the procedure detailed above, all of the hardware on the garment meets the requirements of 6.1.6 of EN 469:2005, i.e. the hardware functions after the test.

Observations

- The outer material of the assembly (Nomex IIIA) was tested to EN 1149-3:2004 "Protective Clothing Electrostatic properties Part 3: Test methods for measurement of charge decay" and was found to have a mean Shielding Factor (S) of 0.80 and a Half Decay Time (t₅₀) of less than 0.01 seconds, which meets the material requirements of EN 1149-5:2008 "Protective clothing. Electrostatic properties. Material performance and design requirements". However, the full garments have not been assessed according to EN 1149-5.
- The PROTECSAFE Fire Fighter Suits meet the requirements of Annexes B.1 and B.2 of EN 469:2005 (Visibility) for area of retroreflective and fluorescent respectively, as required by Clause 6.14 of EN 469. The area of material was calculated as 0.138 m² of retroreflective and 0.224 m² of fluorescent.
