



SINGLE USE ISOTONIC DRINK

INGREDIENTS Sugar, dextrose, maltodextrin, acid citric acid (E-330), anti-caking agent silicon dioxide (E-551), sodium chloride, L-ascorbic acid, flavouring, calcium salt of orthophosphoric acid, DL-alpha-tocopheryl acetate, potassium citrate, sweetener sucralose (E-955), nicotinamide, magnesium oxide, zinc sulphate, pyridoxine hydrochloride, phyloquinone, pteroylmonoglutamic acid, potassium iodide, sodium selenate, cholecalciferol, cyanocobalamin.

DESCRIPTION Isotonic and energy drink that provides the carbohydrates and minerals needed during and after physical exertion.

INSTRUCTIONS FOR USE Dissolve the contents of the sachet in 250 ml of water. Stir with a spoon and consume.
