- b) Technology ensuring leukocyte reduction to obtain the finished product without leukocyte contamination.
- c) AC needle type 17 G with a lateral fissure.
- d) Post-donation needle cap system for subsequent harmless use.

2) Anticoagulant solution:

- a) Plastic container.
- b) Volume of 500 ml.
- c) Sterile and pyrogen-free.
- d) Equipped with an element for securing the container in a holder.
- e) Contains citrate and dextrose.

- 3) Laboratory blood sampling system:
- Vacuum tube holder and needle.
  - Integrated into the closed and sterile collection tubing system.
  - Equipped with a clamp.
- 4) Container for platelet collection and storage:
- The consumable kit contains 2 containers for platelets.
  - Allows for the collection of two doses of platelets from the donor.
  - Provides automatic collection of platelet concentrate into plastic containers, without additional mechanical manipulation during the collection process.
  - Upper connection port for connection to the transfusion system.
  - Lower slot for suspending the container in the transfusion holder.
- 5) The platelet collection set is equipped with a reservoir/vial for collecting platelet samples for quality control examination, with a maximum capacity of 10 ml.
- 6) Container for plasma collection and storage:
- One container provided.
  - Capacity of the plasma bag: 1000 ml.
  - Two orifices on the top for securing it in the blood component separation device.
  - Upper connection port for connection to the transfusion system.
  - Lower slot for suspending the container in the transfusion holder.
  - The connection tubing to the anticoagulant solution is equipped with a filter.
