THIS CONTRACT AGREEMENT is made on the 24 day of September, 2020.

## BETWEEN

  - (iii) Promintergaz SRL, a corporation incorporated under the laws of Republic of Moldova and having its principal place of business at 19 Dacia blvd., Chisinau, Republic of Moldova (Partner)

  - (h) the completed Schedules and any other documents forming part of the Contract

  Agreement, the Contractor hereby covenants with the Employer to execute the Works and to
  remedy defects therein in conformity in all respects with the provisions of the Contract.
