have agreed as follows:

(1) Subject

The subject of this Contract is providing support within the framework of the "Visibility of EU and EU assistance in the Republic of Moldova in 2023" project implemented by Particip GmbH (EU specific contract number: NEAR/KIV/2022/EA-SP/0150). Particip's internal project code is 22-0179-000-MDA-VISI-COM-23.

The contractor declares to know and accept the conditions of the main contract and specific ToR for this assignment and will carry out her/his duties in conformity with these.

(2) Scope of services

The Contractor will:

All services under this contract are detailed in Annex 1.

(3) Total budget

This Contract is established in EUR, for a maximum amount of **112621,96 EUR**. The contractor will pay its staff in an adequate manner for the provision of services related to this contract, thus:

- 50000 EUR of the total amount will be paid by "Strategic Communication and Support to Mass-Media" (StratCom) project;
- Particip pays the remaining amount of 62621,96 EUR, with the right to make and pay directly to certain service providers, in agreement with the provider, e.g. volunteers, moderators, interpreters and others.

(4) Commencement Date

1st May 2023

(5) Period of execution

The overall period of execution is 1 month.

(6) Reporting

The Contractor shall provide reports on progress upon request by Particip.

- (7) Payments and Bank Account
- 8.1 Payments will be made in Euro into the bank account notified by the Service Provider, based on a correct and complete invoice from the Service Provider to Particip, corresponding to the provided template.
- 8.2 The payments will be made according to the following schedule:

Payment is made in two stages.

Stage 1: advance payment of 50% of the total contract value wil be processed until May 5th.

Stage 2: payment after delivery of all requested services and their approval by Particip and the EU Delegation to the Republic of Moldova.

Payments will be made within 15 working days upon receipt of a correct and complete invoice by Particip.

In case of an audit, the Contractor will provide requested information on its services to the auditor and Particip upon request. If the relevant information cannot be provided in a timely manner and this has financial consequences for Particip, the Contractor agrees to indemnify Particip accordingly.

(8) Unsatisfactory performance

In the event that the Contractor is not fulfilling his contractual obligations or is performing unsatisfactorily, Particip is entitled to suspend payments to the Service Provider for as long as the delivery of his services and outputs remains unsatisfactory to the EU Delegation or Particip.

(9) Insurances

The Contractor declares that for the entire duration of this contract he has full coverage of all necessary insurances according to Article 13 of the General Conditions governing FWC COM 2015.

The costs of these insurances are covered by the fees agreed on above. The Contractor declares that she has no claims towards Particip to cover any such costs. The Contractor will indemnify Particip against any possible claims made by the Contracting Authority or any other party in connection with the insurance coverage of the Contractor.

(10) General Obligations of the Contractor

10.1 The Contractor shall perform the services with due care, efficiency and diligence, in accordance with the best professional practices and in compliance with all contractual documents

10.2 The Contractor shall respect and abide by all laws and regulations in force in the country of operation. The Contractor shall indemnify Particip against any claims and proceedings arising from any infringement by the Contractor of such lawy and regulations

10.3 For the duration of this contract, the Contractor shall respect the political, cultural and religious practices prevailing in the country of operation.

10.4 The Contractor shall at all times act loyally and impartially and as a faithful adviser to all relevant institutions in the country of operation in accordance with the rules and/or code of conduct of her/his profession as well as with appropriate discretion.

10.5 The Contractor shall respect the principles relating to processing of personal data pursuant to Art. 5 (1) General Data Protection Regulation. This provision applies to all personal data the Contractor gets access to or knowledge of in the frame of his/her assignment with Particip and shall remain in force after the termination of this contract. The Contractor ensures prior consent from individuals featured I the outputs.

10.6 The Contractor shall not have the benefit, whether directly or indirectly, of any royalty or of any gratuity or commission in respect of any patented or protected article or process used in or for the purposes of this contract or the project, unsless it is agreed by Particip in writing that she/he may. The title rights, copyrights and all other rights of whatsoever nature in any material and documents prepared by the Contractor in the performance of this contract shall be confidential and shall be the absolute property of the Contracting Authority of the main contract. However, particip may delegate its rights to a third party, if convenient. The contractor shall, upon completion of this contract, deliver all such documents and data to Particip. The contractor may retain copies of such documents and data, but shall not use them for purposes unrelated to this contract without prior written approval of Particip

(11) Termination of the contract

- 11.1 Particip may terminate this contract with the Contractor without notice and with the corresponding reduction of duties and remuneration of the Contractor, in any of the following cases:
 - the Contractor refuses or neglects to carry out administrative orders given by the European Union Delegation or by Particip;
 - the European Union Delegation requests Particip to replace the Contractor for whatever reason or expresses serious discontent with the services provided by the Contractor;
 - the European Union Delegation terminates the main contract (mentioned in § 1) with Particip or reduces its scope or duration.
 - The country of operations withdraw the work permit of the Contractor for reasons beyond Particip's control.

Such termination shall be without prejudice to any other rights under this contract. In the event of such termination, the Contractor shall pay particip for any loss or injury Particip may have suffered.

- 11.2 Particip may terminate this contract with the Contractor after giving 7(seven) days notice to the Contractor, and with the corresponding reduction of duties and remuneration of the Contractor, in any of the following cases:
- the contractor fails to carry out the services substantially in accordance with this contract
- the contractor fails to comply within a reasonable time with the notice given by the European Commission, other relevant authorities in the country of operation or by Particip requiring him to make good the neglect or failure to perfom his obligations under this contract which seriously affects the proper and timely performance of the services. Such termination shall be without prejudice to any other rights under this contract.
- 11.3 The Contractor may, after giving 7 (seven) days' notice to Particip, terminate this contract if Particip
 - fails to pay the Contractor the amounts due under the regulations of this contract within 15 work days of receipt of an invoice and its respective supporting documents.
 - consistently fails to meet its contractual obligations after repeated reminders.

- 11.4 Should the main contract be amended, suspended or cancelled for reasons of force majeure which arise after the date of signature of this contract, neither party shall be considered to be in default or in breach of its obligations under the contract. Force majeure shall be defined as in Art. 38.2 of the main contract.
- (12)Law and Language of the Contract
- 12.1 The law of the Republic of Moldova shall govern all matters not covered by the Contract.
- 12.2 The language of the Contract and of all written communications between the Service Provider and Particip shall be English.
 - (13)Tax and Customs Arrangements

The Contract value includes all duties and taxes, if any applicable, but excluding VAT.

- (14)Dispute Settlement
- 14.1 Any disputes arising out of or relating to this Contract which cannot be settled amicably shall be referred to the exclusive jurisdiction of the Court of Chisinau, Republic of Moldova.
 - (15)Other Specific Conditions Applying to the Contract

The Service Provider must take the necessary measures to ensure the visibility of Particip.
