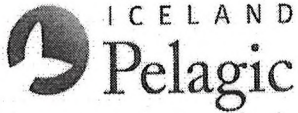
The fish was caught as per international rules and was neither done by means of explosives nor in areas described as being polluted by agricultural fertilizers or industrial wasters or insecticides

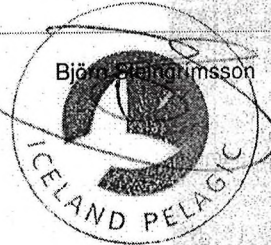
