


Figure 1-1 left of the analyzer




Figure 1-2 front of the analyzer




Figure 1-3 back of the analyzer




2.1 Introduction

C3100 Auto Coagulation Analyzer is a quantitative, Auto Coagulation Analyzer for in vitro diagnostic use in clinical laboratories; it provides Activated Partial Thromboplastin Time, Prothrombin Time, Thrombin Time, Fibrinogen, D-dimer and FDP etc..



2.4 The System Principles

Simulating physiological blood coagulation conditions is the detection principle. Starting the coagulation by adding some reagents can make fibrinogen into cross-linked fibrin. We determine the reaction end point by continuous monitoring physical properties (dual bead magnetic method, plasma viscosity) of reaction system, and using process time as the fibrinogen conversion time. Using this principle, the coagulation characteristics of blood can be measured.


C3100 Auto Coagulation Analyzer use dual bead magnetic method and optical method.

2.4.1 Dual bead magnetic method

The detection system for clotting-time assays on the C3100 Auto coagulation analyzer is based on the increase of viscosity of the plasma being tested. This increase of viscosity is measured through the motion of a stainless steel ball that is made to affect pendular swings on the two curved rail tracks provided in the bottom of the cuvette containing the test plasma.

Constant pendular swings of the ball are created by an electromagnetic field that is applied alternately on opposite sides of the cuvette by two independent coils. The energy of the electromagnetic field can be varied depending on the test being performed. However, as soon as the plasma starts to clot (as a result of the coagulation process being initiated by the addition of the clot starting reagent), the viscosity of the plasma starts to increase, and this change in plasma viscosity affects ball movement, slowing it down. As the viscosity increases, the oscillation amplitude of the ball swing decreases. An algorithm uses these variations in oscillation amplitude to determine the clotting time.

- The interference caused by hemolysis, icterus or lipemia may be eliminated.
- The interference caused by air bubble may be eliminated.
- The interference caused by turbidity sample may be eliminated.




NOTE

- Cuvette and bead are patents. The camber on the cuvette bottom can affect the test result, please use the precil cuvette.
- The cuvette tray should prevent magnetization from magnetic field.
- The cuvette and bead is one-off products.


2.4.2 Optic method

There is a specifically bound characteristic between antigen and antibody; we use this feature to make test sample unite with Antibody particles. The content can be known through test the variation in light intensity.

The end point detection is determined by the change of the transmitted light. The optical source, sample and detector are in a straight line, the light intensity will gradually increase by reason of the formation of the fibrin clot.

The PC software only shows the level 1 menus, and you can enter the level 2 screens by using the sub-menu buttons in the button area.

2.6 Reagents, Controls and Calibrators

As the analyzer, reagents, controls and calibrators are components of a system, performance of the system depends on the combined integrity of all components. You should only use the precil specified reagents, which are formulated specifically for the fluidic system of your analyzer in order to provide optimal performance. Do not use the analyzer with reagents from multiple suppliers. In such use, the analyzer may not meet the performance specified in this manual and may provide unreliable results. All references related to reagents in this manual refer to the reagents specifically formulated for this analyzer.

Each reagent package must be examined before use. Product integrity may be compromised in package that has been damaged. Inspect the package for signs of leakage or moisture. If there is evidence of leakage or improper handling, do not use the reagent.

NOTE

- Store and use the reagents as instructed by instructions for use of the reagents.
- Pay attention to the expiration dates and open-container stability days of all the reagents. Be sure not to use expired reagents.

2.6.2 Controls and Calibrators

The controls and calibrators are used to verify accurate operation of and calibrate the analyzer.

The controls are used to verify that the analyzer is functioning properly. Daily use can verify the operation of the analyzer and ensures reliable results are obtained. Read and follow the instructions for use to use the controls and calibrators.

All references related to controls and calibrators in this manual refer to the controls and calibrators specifically formulated for this analyzer by precil. You should buy this controls and calibrators from precil and precil-authorized distributors.

Chapter 3 Installing Your Analyzer

3.1 Introduction



- Installation by personnel not authorized or trained by precil may cause personal injury or damage your analyzer. Do not install your analyzer without the presence of authorized personnel.
- The installation, test, update, and modification of the software associated with the analyzer shall only be performed by personnel authorized by precil.

The analyzer is checked and packed with care before it is shipped from the factory. Inspect the carton carefully after arrival. If you see any sign of damage is found, contact precil or your local distributor immediately.

After opening the package, check the delivered goods against the packing list, and then visually check the system appearance. If you find anything missing or damaged, contact precil or your local distributor immediately.

3.2 Installation Requirements

3.2.1 Space Requirements

While install your analyzer, make sure there is enough space left for service and maintaining operations, as well as for the analyzer to dissipate heat and for the fluidic tubing to be properly placed without extrusion. Specific requirements shown as follows:

- Proper high to place the analyzer;
- At least 500 mm to each side of the analyzer;
- At least 600 mm above the analyzer;
- At least 250 mm behind the analyzer;
- The supporting table where the analyzer is placed shall be able to withstand at least 100 Kg of weight.

3.2.2 Power Requirements



- Make sure the analyzer is properly grounded.
- Before turning on the analyzer, make sure the input voltage meets the requirements.



- Using pinboard may bring electrical interference and the analysis results may be unreliable. Please place the analyzer near the electrical outlet to avoid using pinboard.
- Please use the original electrical wire shipped with the analyzer. Using other electrical wire may damage the analyzer or cause unreliable analysis results.

- Do not place the analyzer near brush-type motors, flicking fluorescent lights, and electrical contacts that regularly open and close.
- Do not place the analyzer in direct sunlight or in front of a source of heat or drafts.
- The environment should be well-ventilated.
- Do not place the analyzer on a slope.

3.2.4 Transportation and Installation



 Installation by personnel not authorized or trained by precil may cause personal injury or damage your analyzer. Do not install your analyzer without the presence if authorized personnel.

The transportation and installation shall be conducted by precil – authorized personnel. Do not transport or install the analyzer without contacting precil or your local distributor.

3.2.5 Cuvette Tray Installation




Figure 3-1 Install the cuvette tray

User can install the cuvette tray according to the figure 3-1.

- Push the cushion to the rear, lift up the open plate and close plate.
- Open the cover plate
- Put the tray and scroll on the two gearwheels, straining the cuvette tape with counterclockwise.
- Lay flat open plate toward left and then push toward right to the bottom. Lay flat the close plate and cover plate.

NOTE

- The cuvette tape should be placed in the middle position.
- The cuvette tape should be extracted between cover plate and tape guide pin.
- Do not discard the cushion when change tray.

CAUTION

- Please push carefully when change the tray.
- Discard the cuvettes in the cup slot.
- Do not wreck cuvette tape.

3.3 Install the Analyzer

3.3.1 Liquid Line



- Be sure to dispose of reagents, waste, samples, consumables, etc. according to government regulations.
- Wear proper personal protective equipment (e.g. gloves, lab coat, etc) and follow safe laboratory procedures when handling them in the laboratory.
- If the waste accidentally spill on your skin, wash them off with plenty of water and if necessary, go to see a doctor; if the reagents accidentally spill into your eyes, wash them off with plenty of water and immediately go see a doctor.

NOTE

 Please discharge the waste into a container and dispose it according to government regulations.

Connect the containers to the analyzer as shown in the following figure. Be sure to keep all connecting lines isolated from anything electrical.




Figure 3-2 connecting line







Chapter4 Setting Your Analyzer

4.1 Introduction

The C3100 is a flexible laboratory instrument that can be tailed to your work environment. You can customize the software options as introduced in this chapter.

For the security of the setting and data, two access levels are provided to the operator of the analyzer. The administrator access level provides the operator with access to more functions or settings, some of which can be configured to be accessible to operators.

This chapter introduces how to customize the settings of the analyzer and the PC, some of which will be performed only occasionally.

4.2 Analyzer Introduction




Figure 4-1 appearance

The appearance of C3100 is showed as figure 4-1.





Figure 4-2 left panel

4.3 Software Introduction



4.3.1 Menu area

At the upper part of the software window are seven menu options: "Sample analyze", "Review", "QC", "Calib", "Service", "Setup" and "Log", all which are interpreted respectively as follows.

4.4 sample analyze



4.4.1 Work List

The Work List locates on the left of the screen. It includes the following main functions:

■ Sample testing state

The sample testing state and results are displayed on the left of the screen.

If the sample has a barcode and the LIS is connected properly, a worksheet is generated on the left.

Editing sample testing

You can edit the testing project when the generated worksheet is in non-testing state. You click a sample or select a sample location in the sample area to show experiment editing options in the sample information window on the right.

To edit testing projects of multiple consecutive samples at one time, you can select the required ones by dragging the cursor on the left or in the sample area, and edit the information in the sample information window on the right.

■ Data information

In the testing state area, you can double-click the target sample whose testing is complete to

return to the **Review** screen.

For details, see the introduction to Review.







■ After you select a sample, click uto show the position setup window.



After the sample to be moved is selected, select the target position where no tube is placed. The sample is moved to the target position.

To perform a non-barcode sample testing, you need to perform the following operations first:

■ Load the sample in the target position.

Choose **Add Sample**, select a sample, and click . Then, select a target position.

No samples being loaded

If no samples have been loaded, choose **Add Sample** and load the sample in the automatically generated position.



4.4.4 Tube Type

■ The software takes by default that samples use long tubes. If short tubes are used to hold the samples, you need to click **Short Tube** after you select the sample.



• Make sure that the selected tube type is consistent with the actual one after the tube is replaced; if not, the instrument may be damaged and cannot be repaired.


4.4.5 Emergency

■ The samples from emergency clinic departments can be analyzed in higher priority than samples from other departments.



- During analysis and processing, perform the following steps to implement a sample analysis on emergency samples:
- 1. Select a sample, for example, the sample in position E-1 in the figure below.

- 2. Click **Emergency**, and the sample in the position is changed to an emergency sample.





4.4.7 Patient Information

- After the LIS system connection is normal and the bar code is scanned successfully, the patient information is automatically loaded here.
- The information about the reviewer and review time is loaded automatically after the sample is reviewed.
- You can add quick inputs and new fields by choosing **Setup** > **Data Dictionary** and **Customized Setup**. For details, see "Data Dictionary" and "Customized Setup" under "Setup".
- After the samples are reviewed under **Review**, the patient information cannot be modified.
 - You can click **Cancel Review** under **Review** to re-edit the patient information.
- You can press Enter in any edit area to shift sample.



Pause: You can click **Pause** if you need to change reagents or perform other operations.

The instrument cancels tests not started and carries on the ongoing ones to finish the analysis after you click **Stop**.

4.7 QC

NOTE

• Setting the Quality control blood plasma before QC. The setting details please see "Chapter 4 4.5.5 Quality control blood plasma".

Analysis of the results with statistical methods allows the inference that sample results are reliable. Precil recommends you run the QC program daily with normal and high level controls. A new lot of controls should be analyzed in parallel with the current lot prior to their expiration dates. The QC files calculate the mean, standard deviation and coefficient of variation for each selected parameter.



Use and storage the calibrators according the calibrator introduction.



- Make sure the volume of controls is no less than 0.5 mL;
- Make sure the QC is taken when the analyzer is operated normally and error hint is cleared.
- Do not use the one-off product repeatedly.
- Inspect the controls before QC.



• All the samples, controls, calibrators, reagents, wastes and areas contacted by them are potentially biohazardous. Wear proper personal protective equipment (e.g. gloves, lab coat, etc.) and follow safe laboratory procedures when handling them and the contacted areas in the laboratory.



4.7.2 QC Analysis

To ensure the analysis data reliability, you are recommended to implement QC analysis. Regular QC analysis helps you monitor the stability of the instrument and reagents.

- To learn about how to use the control samples and reagents, see the corresponding instructions.
- Steps to carry out QC analysis:

Set the new sample.

Select the required QC group type.

Select the target position for the control, and place the control in the corresponding position. Select the QC item.

- A broken blood sampling cartridge may result in personal injury and/or biological contamination. Therefore, be careful when you load the blood sampling cartridge to the holder or remove it from the holder. Do not damage the blood sampling cartridge.

4.8 Calibration

This section describes the function of calibration. The process of calibration draws a function curve on the measured parameters based on the analysis results (for example, the coagulation time and optical density change rate dOD).

Each batch of reagents shall have a calibration curve. You can store a maximum of 10 calibration curves for each program.

You need to select the calibration curve of the reagents of the same batch number for the analysis. The software uses the verified curve to calculate the calculation parameter.






- Before changing the reagent batch, you need to calibrate the batch first.
- You need to select the calibration curve of the reagents of the same batch number for the analysis; otherwise, the testing results may be inaccurate.

NOTE

- You must use the calibrators and reagents specified by Precil, and follow the instructions for use of calibrators and reagents strictly during storage and usage.
- The calibration operation is valid only when the calibrator calculation is implemented in the Calibration window.



For the fitting model FIB, select the double logarithmic, and set FDP and D-D to Absorbance difference – Concentration.

NOTE

The default fitting model in the software is recommended for calibration.

Unit of concentration: g/L for FIB. The instruction of use for the calibrator shall prevail.

• Use the default unit in the software for calibration.

• If the unit recommended by the instruction of use for the calibrator differs from the default unit in the software, convert the unit before filling in the parameters.

Reference Filled in based on the instruction of use.







- During a single-calibrator D-dimer calibration, put the calibrator in a bullet-head short tube, and put a clean bullet-head short tube in the position following the calibrator tube, so that the instrument can place the intermediate sample in the second short tube. - You are recommended to adopt manual calibration for D-dimer calibration.

4.9 Services

To help the analyzer operate effectively, you are recommended to take daily maintenance measures on the analyzer based on the description in this section. This analyzer provides multiple maintenance functions for your convenience.


This section describes these maintenance functions and handling measures for faults and alarms.



• The surfaces of all the parts of the analyzer is potentially contagious. Take protective measures during operation and maintenance.



- Improper maintenance may damage the analyzer. Follow the instructions strictly during maintenance.
- For problems not specifically clarified in the instruction, contact Precil Service Department for professional maintenance advices.
- Avoid the dangerous parts, such as the sharp point of a probe, during maintenance.



■ Pipe refill


To ensure the accuracy of the testing results and the cleanness of the tube, carry out tubing perfusion periodically.

Click **Pipe refill** in the following circumstances:

- An air bubble is found in the tube. An air bubble may affect the accuracy of the added sample volume and reagent volume.
- The instrument is newly installed. Before implementing any testing, you need to carry out tubing perfusion first.
- Periodically implementing tubing perfusion for the cleanness of the tubes.




4.11 Logs



Chapter 5 Operating Your Analyzer

5.1 Introduction

This chapter provides step –by step procedures for operating your analyzer on a daily basis. A flow chart presenting the common daily operating process is shown below.




Figure 5-1 flow chart

5.2 Initial checks

Perform the following checks before turning on the analyzer.



• All the samples, controls, calibrators, reagents, wastes and areas contacted by them are potentially biohazardous. Wear proper personal protective equipment (e.g. gloves, lab coat, etc.) and follow safe laboratory procedures when handling them and the contacted areas in the laboratory.

WARNING

- Be sure to dispose of reagents, waste, samples, consumables, etc. according to government regulations.
- The reagents are irritating to eyes, skin and diaphragm. Wear proper personal protective equipment (e.g. gloves, lab coat, etc.) and following safe laboratory procedures when handling them in the laboratory.
- If the reagents accidentally spill on your skin, wash them off with plenty of water and if necessary, go to see a doctor; if the reagents accidentally spill into your eyes, wash them off with plenty of water and immediately go see a doctor.
- Keep your clothes, hair and hands away from the moving parts to avoid injury.

NOTE

- You should only use the precil-specified reagents. Store and use the reagents as instructed by instructions for use of the reagents.
- Before using the analyzer, make sure reagents are properly connected.
- Checking waste bottle

Check and make sure the waste bottle is empty.

■ Checking waste container

Checking tubing and power connections

Specified operation please refer to "Chapter6 6.2 Daily maitenance Checking or cleaning the sample and reagent needles". If the needle's tip is bent, please contact with precil customer service department to replace it.

5.3 Startup





5.4 Reagents

Fit in enough reagents (calculate the volume according to the amounts of tests) and prepare more reagents (it will leave over reagent in every bottle).

Put mixer in PT and APTT reagent bottle (refer to reagent manual).





For the fitting model FIB, select the double logarithmic, and set FDP and D-D to Absorbance difference – Concentration.







To ensure the analysis data reliability, you are recommended to implement QC analysis. Regular QC analysis helps you monitor the stability of the instrument and reagents.

NOTE

- To learn about how to use the control samples and reagents, see the corresponding instructions.
- Steps to carry out QC analysis:

Set the new sample.

Select the required QC group type.

Select the target position for the control, and place the control in the corresponding position. Select the QC item.

The instrument supports long-tube, bullet-head, and short-tube QC.

After the above configuration is made, click **Start** to implement the QC testing.

NOTE


- The batch No. of one control in the same QC group must be the same.
- You need to set the tube type for the control.

NOTE

 You must use the controls and reagents specified by Precil, and follow the instructions for use of controls and reagents strictly during storage and usage.



• When you click **Control Sample**, the instrument carries out daily QC analysis. During a QC testing, the plasma is stored in a short control tube (by default). Make sure that the tube type is correctly set; otherwise, the probe may be damaged.

5.7 Preparing Samples

Put sample tubes into sample racks.



Do not contact patients' sample blood directly.



• All the samples, controls, calibrators, reagents, wastes and areas contacted by them are potentially biohazardous. Wear proper personal protective equipment (e.g. gloves, lab coat, etc.) and follow safe laboratory procedures when handling them and the contacted areas in the laboratory.



- Make sure the sample tube is uncapped before put into sample rack.
- Do not re-use disposable products like cuvettes, reagent bottle, etc.



- To attain accurate analysis results, make sure the sample volume is no less than 1 ml.
- Before running the refrigerated (2°C−8°C) samples, warm them at room temperature for at least 30 minutes.

NOTE

- Be sure to use clean fused silica glass/plastic as test tubes.
- The proportion of blood and NaC₆H₅O₇ 2H₂O is 9:1,improroper proportion would leads inaccurate results.

5.7.1 Samples

Prepare the samples according to the below procedures:

■ Plasma

Take a centrifugal separation for 10-15 minutes with 3000r or 2000 g of centrifugal force.

- Stick sample barcode
- Put the sample tube into rack of analyzer.

5.8 Sample Analysis

Pay attention on the below warnings, please stand to them severely; otherwise it may cause injury or analyzer damage.



- When the analyzer is processing, please:
 - ✓ Do not put the hand in analyzer.
 - ✓ Close the cover.
 - ✓ It may cause data missing and analyzer broken if turn off the analyzer.
 - ✓ Do not change analysis instruction of worksheet after experiment start.

NOTE

- Make sure the cover keep closed when the analyzer is processing, otherwise the instrument would alarm and pause work.
- Open the cover would conduct to inaccurate testing results, especially for optical items.

NOTE

• If the analyzer is ready (working prompts and message prompts) and the temperature is $37\pm0.5^{\circ}$ C, you can begin the analysis.

5.8.1 Clear up sample positions

When shutting down the software or starting it for the first time, a dialog box appears, asking whether you want to save the previous worksheet.

If the worksheet for the current experiment has been completed or a sample has been taken, click **No** to delete the worksheet that has expired.





 After the previous worksheet is deleted, make sure that the Sample area of the instrument does not contain a sample to be cleared.

5.8.2 Setting Experiments and Samples

An experiment sample can be set in two ways, depending on whether the sample has a barcode and whether the LIS system connection is normal.

■ If a sample has a barcode and the bidirectional connection of the LIS system are normal

If all the test tubes on the tube rack have a barcode and LIS system connections are normal, you only need to put the tube on proper position.



 Make sure that the tube is put properly so that the software can read worksheet data correctly from the LIS system.

After the content of the worksheet of all the samples is read from the LIS system correctly, click **Start** to perform the experiment.



The software will estimate the time required for completing the experiment.







NOTE


The instrument supports both long and short test tubes.

By default, the software uses long test tube settings. If a short test tube is used, enable the short test tube settings.




A long test tube refers to an anticoagulated blood sampling cartridge with 3.2% or 3.8% sodium citrate. After the anticoagulant is mixed with blood at a ratio of 1:9, the total volume is about 2 ml or 3 ml. After centrifugation and the cap is removed, insert the test tube on the standard tube rack of the instrument.

The instrument supports $75 \times 12.5 \pm 0.5$ standard blood coagulation tubes.



The short test tube shown in the following figure is supported. It is a 1.5 ml bullet-head centrifugal tube. If the sample is less than 1.0 ml, place plasma in a short test tube for tests or place whole blood that contains a certain proportion of sodium citrate anticoagulant in a short test tube for tests.



WARNING


- It is recommended that you use standard short test tubes along with adapters. Do not place a short tube directly on a rack, so as to prevent inaccurate sample taking due to the inclined test tube.
- The instrument does not support cap puncture. Before using a long test tube for tests, remove its cap to prevent probe damages.
- When using a long test tube or a short test tube with an adapter, make sure that the tube is inserted to the bottom of the rack so that the tube will not collide with the moving probe and damage the probe.

5. Select the experiment type.

To perform a common experiment, click **Start** after the above configuration is made.



To set a sample for an emergency test, click **Emergency** and set the experiment.



If sample values are abnormal or other abnormal situation occurs, you can click **Retest** to perform the test again.

6. Delete or clear samples.

To delete a single sample: You can click **Delete** to delete a selected sample.

To clear all samples: You can clear the worksheet of all the samples in the sample area.

NOTE

• After **Clear** is clicked, you can query the information about the finished sample tests in the **Review** screen, but all the worksheets of unfinished tests are deleted.



Click **Exit**. The reagent is replaced.

To add a reagent for a new experiment, pause the instrument, and follow the instructions in 4.4.10 "Setting Reagents" in Chapter 4 to perform operations.

■ Set consumables.

NOTE

- To ensure accurate testing and reliable operation by the analyzer, this product requires dedicated cuvettes from Precil.
- Cuvettes are not reusable products.



- Store cuvettes according to the requirements in their user manuals.
- Keep cuvettes in dry environments and away from magnetic fields.

The instrument monitors and manages the volumes of reagents and cuvettes. You can check the usage of reagents and consumables in the consumables amount plan.

Swiping the card:

When the reagent amount is low, you need to swipe the card.

Click **Swipe Card**, and follow the instructions.



After the instruction message appears, place the card on the card reading area on the instrument.



After the software indicates that the card is read successfully, click \mathbf{OK} to end the card reading operation.



5.9 Pause/stop analyzer

If reagent addition or reagent position change is required, you can press the Pause key to pause the experiment.

- Press the **Pause** key.
- After the instrument is paused, add reagents or other consumables.
- After the preparation, press the **Start** key to start the experiment.



When you click the **Stop** key, the instrument quickly stops the experiment.



• After you click **Stop**, some of the ongoing testing items may be displayed as empty with their status shown as completed. If you click **Start**, you can get valid data only after you perform retest for those with empty testing results.

5.10 Shutdown

You can click the **Shut Down Host** key to shut down the instrument.



After clicking the **Shut Down Host** key, click **OK** to shut down the host.



When the software is performing host shutdown countdown, you can view the countdown in the area shown in the following figure.



You need to power off the instrument as instructed by the software.

- Performing unauthorized maintenance procedures can damage your analyzer. Do not perform maintenance procedures that are not described in this chapter.
- In case of problems not specified in this manual, contact precil customer service department or your local distributor for assistance.
- Only precil—supplied parts can be used for maintenance. For any questions, contact precil customer service department or your local distributor.
- Exercise caution to avoid contact with the sharp sample probe when performing maintenance

The tool or material used in maintenance:

- Clean duster cloth:
- Alcohol;
- Proper personal protective equipment, e.g. gloves, lab coat, etc.

6.2 Daily maintenance

- Checking or cleaning the sample and reagent needles
- 1. Set the needle cleaning agent in the reagent position settings.
- 2. Press the **Clean Needle** key in the toolbar.



• The sample needle and reagent needle have sharp tips that may be contaminated by a blood sample, quality control material, or calibrator and become biologically infectious. Therefore, do not touch the needles.

Choose **Service** > **Maintenance** to access the maintenance menu.

Click the **Observe Twin-Needle Water Column** button.

Observe the outlet of the sample needle and reagent needle, check whether the water outlet from the sample needle and reagent needle is continuous, whether the direction of the water outlet is consistent with the direction of the needles, and whether the volume of the outgoing water is normal

If not, clean the sample needle. For details, see section 6.5 "Unscheduled Maintenance."

- Checking or disposing cleaning agents, waste liquid, and used cuvettes



6.3 Weekly Maintenance

■ Cleaning the outer surface of sample and reagent needles

Make sure that the instrument has been powered off.

Move the sample needle and reagent needle up to the highest point.

Pull the probes to the end of the slideway.

Use a piece of gauze containing deionized water to scrub the outer surface of the sample needle and reagent needle from top to bottom, especially the tips, until the outer surface is clean.

After the cleaning, close the instrument cover and power on the instrument. The instrument performs resetting.

Do not shake the probe when cleaning.

Cleaning the instrument

You must regularly clean the instrument, including its test tube rack, reagent panel, and reaction position panel.

- The instrument surface may possess potential biological dangers in the form of infection. Wear gloves when cleaning it. Use a disinfectant to clean your hands after cleaning the instrument surface.

Make sure that the instrument has been powered off.

Use a piece of clean gauze to scrub the panels. When necessary, use a piece of gauze with a little clean water or disinfectant to scrub the panels.

If a waste liquid bucket is used, remove the waste liquid bottle cap and check whether the waste liquid float is dirty. You can soak it in disinfectant liquid for 10 minutes for cleaning.

6.5 Annual Maintenance

Lubricating moving components

Check the moving components.

Check the X optical axis, Y optical axis, Z guide screw, and linear slideway of the twin-needle moving component and use a little grease to lubricate them.

Check the Y linear slideway and Z linear slideway of the jaw moving component and use a little grease to lubricate them.

Check and lubricate the linear slideway of the horizontal cuvette delivery component.

Check and lubricate the guide screw of the syringe component.

6.6 Irregular Maintenance

Perfusion

If the instrument has not been used for a long time, the cleaning liquid needs to be added for hoses before the instrument begins analysis.

- 1. Before perfusion, connect to the external cleaning liquid and waste liquid bucket.
- 2. Click the **Perfuse** key in the toolbar.

■ Cleaning the sample and reagent needles

If the flow at the tip of a needle is abnormal, use an acupuncture needle to pierce through the tip to remove unexpected objects from the needle.

8.1 Introduction

This chapter lists the cautions to make sure getting safe, availability and precise results.

8.2 Cautions

- 1) Clear the waste water bottle and add cleaning solution, reagents timely.
- 2) Please replace cuvette reel on the right of instrument timely, for the sake of avoiding cuvette lock.
- 3) The default test tube is short when having quality control test.
- 4) The power supply must be earthed.
- 5) Make sure to let the instrument on a stable operation table, no vibration and shaky is permitted. No electro-magnetic interference, no etching gas.
- 6) Do not disassemble the instrument privately; it should be permitted by engineer.
- 7) Precil cuvette and test tube should be used.
- 8) Wrapping box should be preserved for the sake of reuse.
- 9) A special computer should be equipped, for safeguard program and data, antivirus software is needed.
- 10) User should not touch the interior component when the instrument is operating.
- 11) User can only use the power line provided by Manufacturer, otherwise the instrument capability and personal safe cannot be guaranteed.
- 12) Any object cannot enter the air vents on the rear cover.
- 13) Input power: 200VA; Do not collinear with high-power electrical appliances.
- 14) The cleaning piping shall be connected tightly and should not have knots, for avoiding the cleaning solution leak, personal injury and instrument damage.
- 15) Please use the original electrical wire shipped with the analyzer.
- 16) Use precil or precil authorized reagents. Refer to the reagent manual for using and storage.
- 17) Do not delete the current user.
- 18) Use the original or specific external equipment.
- 19) Use and storage the analyzer in specific environment.
- 20) This chapter is not a complete service manual and is limit to problems that are readily diagnosed and / or corrected by the user of the analyzer.

Chapter 9 Storage and Transport

Be sure to store the instrument in a room with the temperature of $-20^{\circ}\text{C} \sim 55^{\circ}\text{C}$, the relative humidity of less than 85%, no etching gas, and having good ventilation.

Please put the instrument in precil container when it is removed.

- Temperature 5° C \sim 55 $^{\circ}$ C
- Relative humidity $\leq 85\%$
- Atmospheric pressure 86 kPa ~106 kPa

The transportation shall be conducted by precil authorized personnel. Do not transport the analyzer without contacting precil or your local distributor.

NOTE

- All the samples, controls, calibrators, reagents, wastes and areas contacted by them are potentially biohazardous. Wear proper personal protective equipment (e.g. gloves, lab coat, etc.) and follow safe laboratory procedures when handling them and the contacted areas in the laboratory.
- Do not contact patients' sample blood directly.

The plasma used in test should be disposed according to the local law. The waste liquid contains biological and chemical composition; it is strongly recommended that gloves should be wearied before use the instrument. Used test cup should be treated as introgenic waste.

1 Warning



- Please check the firmness of all the doors and covers before running the analyzer.
- Make sure all the safety measurements are adopted. Disabling any safety device or sensor is prohibited.
- Please take action to any alarm and problem indication immediately.
- Do not touch the moving parts.
- Contact precil or precil-authorized distributors in time if any damaged part is found.
- Be careful when opening/closing and removing/installing the doors, covers and boards of the analyzer.
- Discard analyzer according to government regulations.
- To avoid damage, do not turn on / off the power of the analyzer continually in a short time.
- Do not contact patients' sample blood directly.
- Store and use the reagents as instructed by instructions for use of the reagents.
- Pay attention to the expiration dates and open-container stability days of all the reagents.

 Be sure not to use expired reagents.
