The project aimed to close all Edenred operations in Moldova (client's portfolio migration, sell of the assets, company winding up) as result of legislative changes with significant negative impact on meal vouchers market (March 2020 – June 2020).

Main activities and results:

- Managed the migration of the company clients portfolio to Up Servicii, an Edenred competitor, ensuring a smooth and timely transition for all the stakeholders despite of the Covid19 pandemic limitations:
- Coordinated the complex activities aiming to increase the use of meal vouchers in circulation to
 ensure that all the employees fully benefit of them and no vouchers will remain in use by end of
 June / mid of July.
