The Public Services Agency (PSA) notifies about the results of the evaluation of the bids submitted and the award to the successful bidders within the open tender procedure no. [ocds-b3wdp1-MD-1718109429947](#) of July 30, 2024 for the procurement of *blanks of identity documents of the national passport system, driving licenses and registration certificates for the period 2024 – 2029*.

According to the decision of the Working Group for public procurement of the PSA, the economic operators whose bids meet all the requirements set out in the award documentation and the "lowest price" award criterion are designated the winners of this public procurement procedure with the awarding of contracts, as follows:

- For lot no. 1 *Blanks of the passport / travel documents (TD3 format)* - **Mühlbauer ID Services GmbH** with the bid price - 11 130 907.00 Euro (excluding VAT);
- For lot no. 2 *Cards on polycarbonate base support with / without embedded chip (ID-1 format)* – **SELP SAS** with the bid price 4 027 125.00 Euro (excluding VAT)

The economic operators **UAB "Garsu pasaulis"**, **Polska Wytwórnia Papierów Wartościowych S.A.** and **Veridos GmbH** proposed bids with higher prices compared to the accepted and compliant bids of the winning economic operators.

The winning economic operators - **Mühlbauer ID Services GmbH** and **SELP SAS** are requested to submit:

- The Performance security of the contract in the amount of 10% of the total amount of the contract (*for non-resident economic operators the value added tax*

(VAT) *does not apply*), according to the provisions of article 68 paragraph (8) of Law no. 131/2015 on public procurement, before the signing of the public procurement contract, a fact provided for in the tender documentation, as, in case of failure to submit the performance security, or in case of the refusal to sign the contract within the period established in the tender documentation, the PSA has the obligation to retain the Bid security;

- The Declaration on own responsibility confirming the identity of the beneficial owners and their non-compliance in a situation of conviction for participation in the activities of a criminal organization or group, for corruption, fraud and / or money laundering, within 5 days after the date the results of public procurement procedure are announced. The winning bidder will send this Declaration to the contracting authority and Public Procurement Agency (electronic copy of the hand-signed paper document without the application of the electronic signature or the document confirmed by electronic signature of the economic operator (electronic signature recognized on the territory of the Republic of Moldova)
