The subject valves are also manufactured respecting design and production processes in compliance with requirements of **UNI EN ISO 9001:2015** standard.

that the ball valves here identified, in application of the above-mentioned technical requirements and prescriptions, are also accompanied by sufficient use instructions and are not "CE marked" since they have characteristics lower than the limits given at paragraph 1, letters a), b) and c) and at paragraph 2 of PED 2014/68/UE Directive.
