

STANDARD FORM OF THE SINGLE PROCUREMENT DOCUMENT FOR EUROPEAN PROCUREMENT

1. The European Single Procurement Document (hereinafter referred to as the ESPD) is a self-declaration by which the economic operator confirms that it meets the qualification and selection criteria required in public procurement procedures in the Republic of Moldova.

2. The form shall be completed, electronically signed, and submitted to the contracting authority when submitting the tender.

3. A DUAE submitted by an economic operator in a previous public procurement procedure may be reused, provided that the information contained in the form is correct and valid on the date of its submission.

4. A tenderer who submits false information in the ESPD or whose supporting documents do not confirm the information indicated in the document submitted shall be excluded from the public procurement procedure and/or may be held liable in accordance with the law.

5. The DUAE form consists of 7 chapters, namely:

1) Chapter I. Information on the public procurement procedure and the contracting authority/entity;

2) Chapter II. Information on the economic operator;

3) Chapter III. Grounds for exclusion from the public procurement procedure;

4) Chapter IV. Criteria for the qualification and selection of economic operators;

5) Chapter V. General guidelines for the selection criteria for economic operators;

6) Chapter VI. Pre-selection of candidates for the public procurement contract award procedure;

7) Chapter VII. Final declarations.

6. Submission of the DUAE form with the tender that does not comply with the requirements set out in the tender documentation will result in the rejection of the tender.

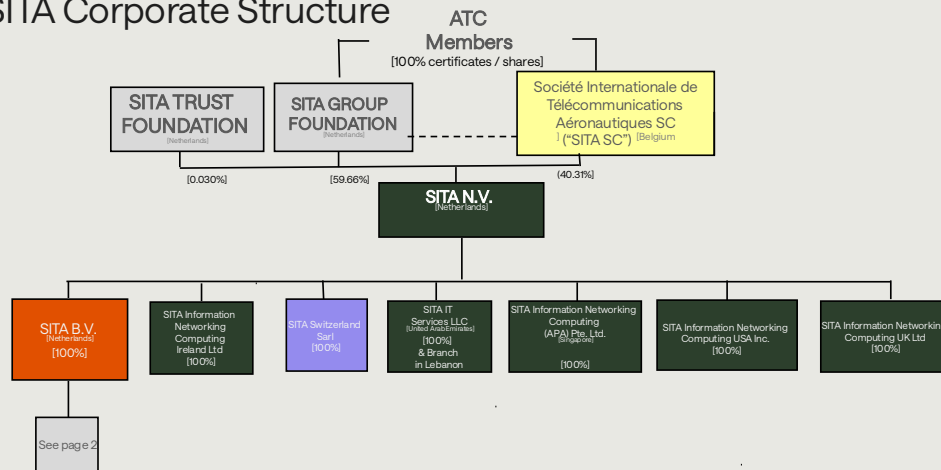

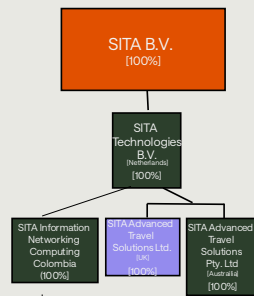
