Performing regular visual inspections of membranes and keeping accurate records of recommended shelf life can reduce the risk of membrane deterioration. Shelf-life limited when kept above +25°C. Verify on a regular basis expiry dates of stored materials, housekeeping, temperature and humidity. Designated "Flammable Material" storage areas must be engineered according to local regulations.
