CT-7 LEG TRACTION SPLINT

INSTRUCTIONS FOR USE



1.)

1.) PREPARE:
Open zipper. Remove ankle hitch from bag, this will be applied first.

Remove splint from bag. Hold upright and allow tubes to intersect. Lay alongside patients injured leg.



2.)

2.) SIZE THE SPLINT

Top of splint should be near the patient's hip crest, bottom near the patient's foot. If necessary, remove **Ischial Cap** and add or subtract a tube to shorten/lengthen the splint. Replace cap.

[-1 tube section (shown), works for most adults 5ft - 6'2ft]

3.) APPLY HITCH

On the ankle hitch, make sure the buckle is pointed toward patient's foot.

Wrap **TIGHTLY** around base of ankle. Buckle should be on **OUTSIDE** of leg.

4.) ATTACH SPLINT

Connect buckle at bottom of splint to the ankle hitch.

5.) ATTACH GROIN/ISCHIAL STRAP

Unclip one side of the Ischial Strap and wrap around the top of the patients inner thigh. Clip buckle back onto splint.

7.) TIGHTEN GROIN STRAP
Locate tail of strap, stabilize with free hand, and pull TIGHT away from buckle. Should fit snug around patients leg.

8.) ATTACH LEG STRAPS
Slide one end of each strap beneath the patient's injured leg (use crevice below knee), place other side of strap on top the leg. Move in position above the knee and connect strap with medium pressure. Repeat this process, applying the second strap below the knee. (No straps directly over a break)



9.) TRACTION
Spin traction mechanism in direction of arrows until appropriate traction is applied.
-Legs should be equal length.
-Reduce swelling at point of injury
-Increase patient comfort/relief.

Same process for below the knee application. Shorten splint accordingly and wrap ankle hitch tightly to proximal calf or patella position.

MONITOR: CSM (circulation, sensation and motor function) closely and adjust as needed.



Cleaning and Disposal Instructions:

The CT-7 should be thoroughly cleaned by washing with warm water and disinfectant and then wiped down with a clean rag after each use. If the device is heavily contaminated, place in bio-hazard bag and dispose according to your hazardous waste protocol. Individually contaminated Ischial/groin strap, leg straps or ankle hitches, can be removed from the device and laundered or be specifically replaced.

Contraindications and Warnings:

Traction should not be used for hip, pelvis or humerus fractures unless a test spin of traction provides immediate pain relief or return of perfusion. Also, traction should be avoided for grossly open and contaminated fractures. If the splint comes in contact with toxins like organophosphates, radioactive material or excessive bodily fluids, then it should be disposed of as deemed appropriate for hazardous materials or biological wastes. If it can be washed and sanitized then reuse is acceptable.
