Dear business partner,

With this document, we confirm that in accordance with the EU Directive (94/62EC) and the Decree on the Management of Packaging and Packaging Waste (Official Gazette No. 84/2006 and 106/2006) adopted in Slovenia, we have regulated our responsibility for packaging and packaging waste.

In order to evaluate the declaration of conformity, the Decree on the Management of Packaging and Packaging Waste (Official Gazette No. 84/06), which contains the data from SIST EN 13427, was used.

Based on the results of testing and the guaranteed production processes, we give a statement of conformity that our product (the base material of the product is paper) complies with the above-mentioned provisions of the EU Directive (94/62EC) and the Decree on the Management of Packaging and Packaging waste adopted in Slovenia (Official Gazette of the Republic of Slovenia No. 84/2006 and 106/2006).

The declaration of conformity is given on the basis of the documentation of the National Laboratory for Health, Environment and Food (NLHEF), certificates and analyzes of our suppliers of raw materials and internal documents, which prove this and, at your request or request by the competent authorities, we pass it on or enable an insight into it.

Contents of hazardous substances in packaging (Compliance with SIST CR 13695-2 standard and Directive 94/62EC – production and assembly requirements – Packaging does not contain hazardous substances

Reusable packaging – (Compliance with the SIST EN 13429 standard - reusable packaging) – Packaging is intended for single use

Allowed processing of packaging with material recycling – (Compliance with the SIST EN 13430 standard - packaging suitable for material recycling) – Packaging is suitable for recycling with material recycling

Enabling energy processing of packaging – (Compliance with SIST EN 13431 standard – packaging suitable for energy recovery) – Packaging is not suitable for energy recovery

Enabled organic decomposition of the packaging – (Compliance with the SIST EN 13432 standard – packaging suitable for composting and biodegradation) – Packaging is suitable for composting and biodegradation

Our packaging in which our products are packed is also in accordance with the requirements of the SIST EN 13427 standard.

With this statement, we also inform you that we have transferred the obligations regarding the handling of packaging and packaging waste to Interseroh and that we have an appropriate contract with the waste management company, no. OE186318 of 21.12.2017

The information given in this statement is available on the basis of the actual knowledge of the product and its components, statements and analyzes of the suppliers of materials included in the product and the relevant institutions. The company Papiroti does not assume any liability for deviations from this information as a result of improper use of our product.

This declaration shall be valid until the date on which at least one of the materials used is replaced or the legislative references are changed in order to require a new conformity check.
