Teaming Agreement

(hereinafter: "Mühlbauer")

hereinafter called individually as "**Party**" or collectively as "**Parties**".

Purpose:

RSD and Mühlbauer want to cooperate in the public procurement procedure organized by Î.S. "Aeroportul Internațional Chișinău" (hereinafter "**Contracting Entity**") named "**Automated Border Control (ABC, e-Gate)**", Tender No. 21447609 (ocds-b3wdp1-MD-1751977966815) (hereinafter the "**Project**"). In this course the Parties want to work closely with each other in respect of concluding a contract containing detailed regulations for the cooperation which purpose is RSD being awarded with the Project by the Contracting Entity.

Teaming Agreement:

1. The Parties agree that **RSD** shall act as the prime contractor in the Project and shall be responsible towards the Contracting Entity for the complete technical solution regarding the Project such as implementation of the Project and further maintenance & support services.
2. The Parties agree that **Mühlbauer** shall act as subcontractor of RSD in the Project and shall provide full technical support and expertise during implementation and further maintenance & support period to RSD.
3. Mühlbauer agrees to exclusively cooperate with RSD to qualify for a bid related to the Project as subcontractor of RSD in case RSD has been awarded with the Project.
4. The detailed scope of work of Mühlbauer as well as the detailed terms and conditions of the cooperation with RSD in the Project will be defined in a separate subcontractor agreement between the Parties. Unless otherwise mutually agreed between the Parties, such subcontractor agreement shall reflect the terms and conditions of the prime contract between RSD and the Contracting Entity on a back-to-back basis.

5. Mühlbauer will support RSD in the preparation of the bid in the Project as far as the scope of work of Mühlbauer is affected.
6. Both Parties confirm that the agreed and listed prices are binding for both Parties for the duration of the Project, according to the Offer for "Automated Border Control (ABC, e-Gate)", Achizitii.md ID 21447609, MTender ID ocds-b3wdp1-MD-1751977966815, published on 08 July 2025.
7. The Parties can mutually agree to grant a discount to the End-Customer in writing. In the event that a discount is granted to the End-Customer, the Parties agree that this discount will be granted from the respective share of the Parties.
