- 1.2. The system components are listed and described in the table below:

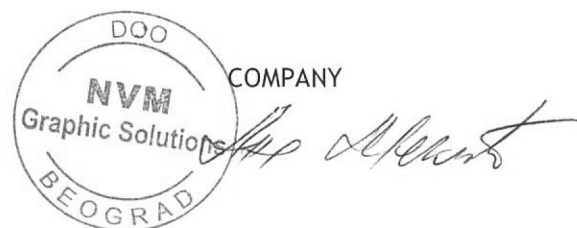
**Appendix 6: Technical Preventive Maintenance**
