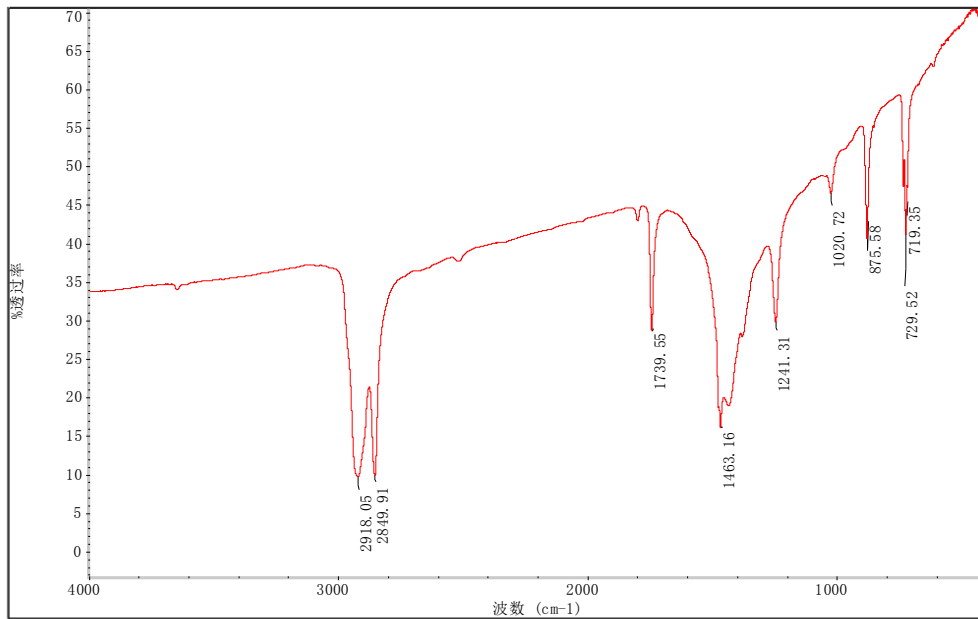


Fig. 1-1 FTIR of the original sample

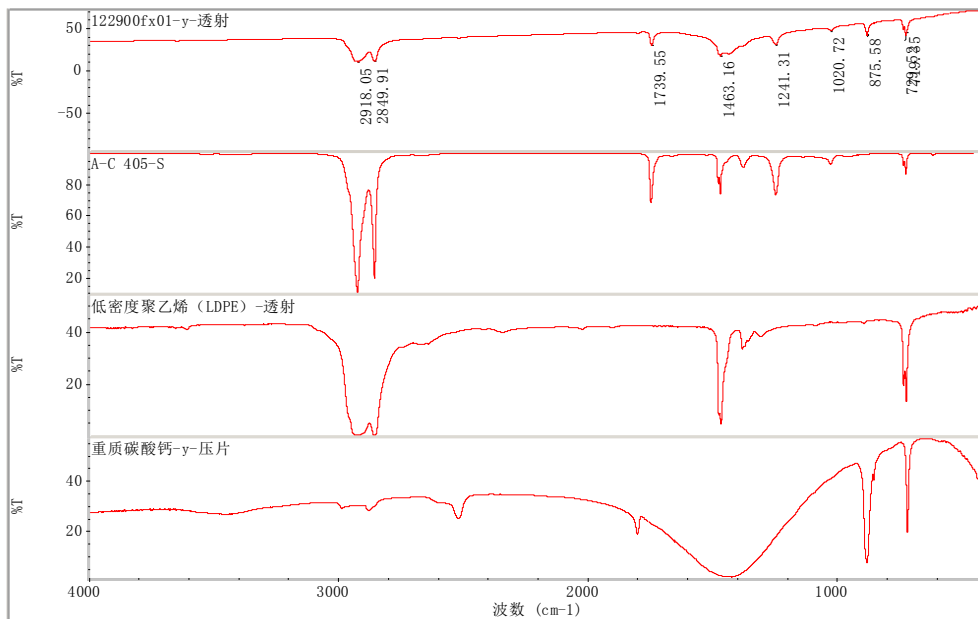


Fig. 1-2 Match FTIR

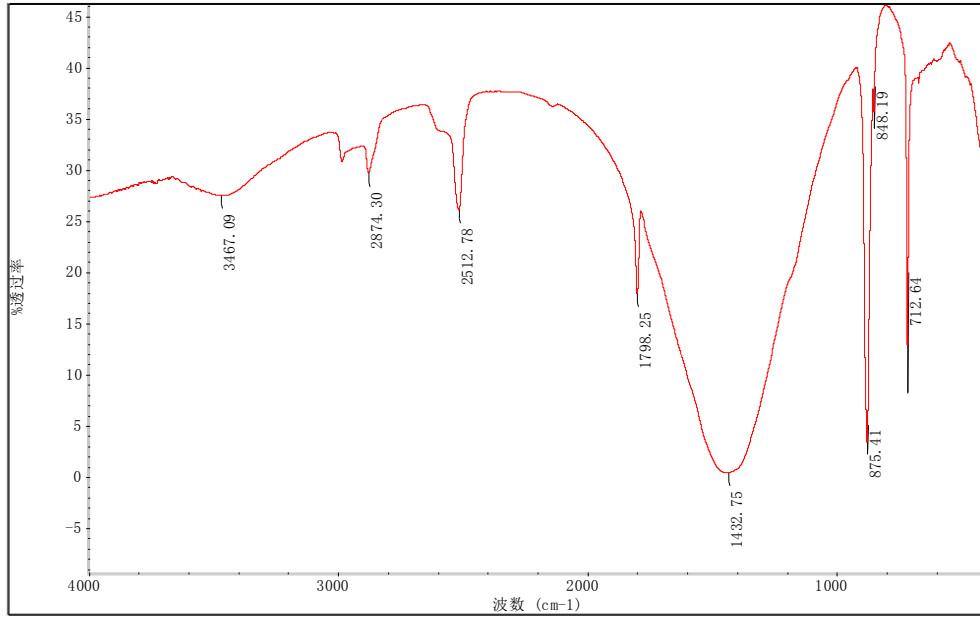


Fig. 1-3 FTIR of the Ash of the original sample

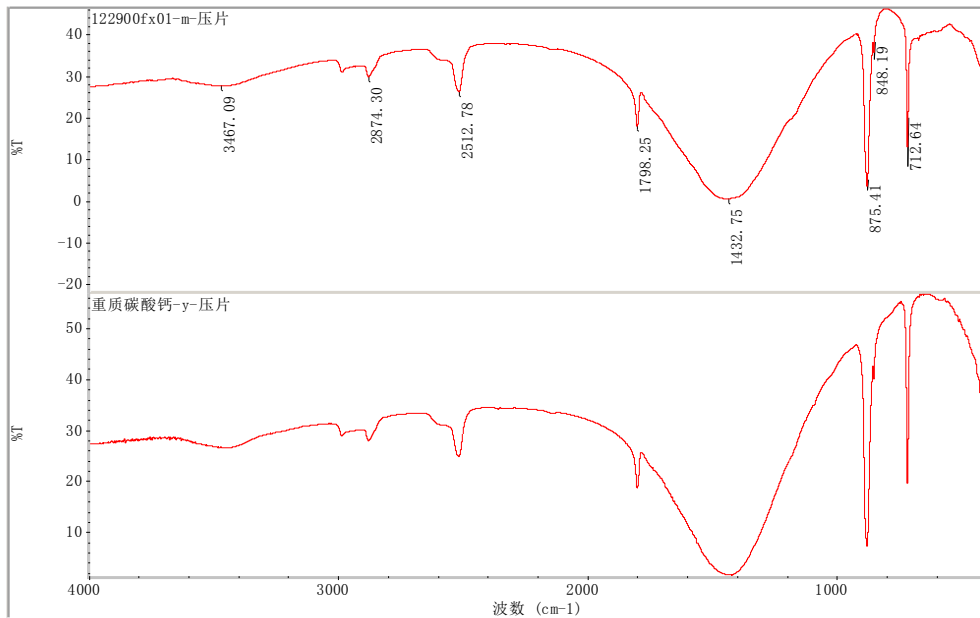


Fig. 1-4 Match FTIR

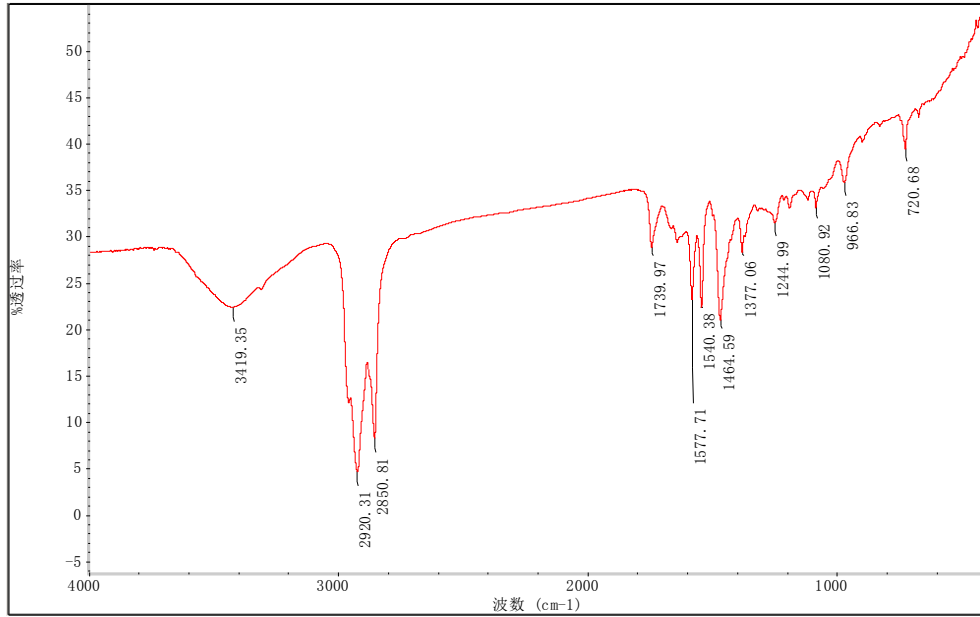


Fig. 1-5 FTIR of the chloroform soluble methanol soluble matter

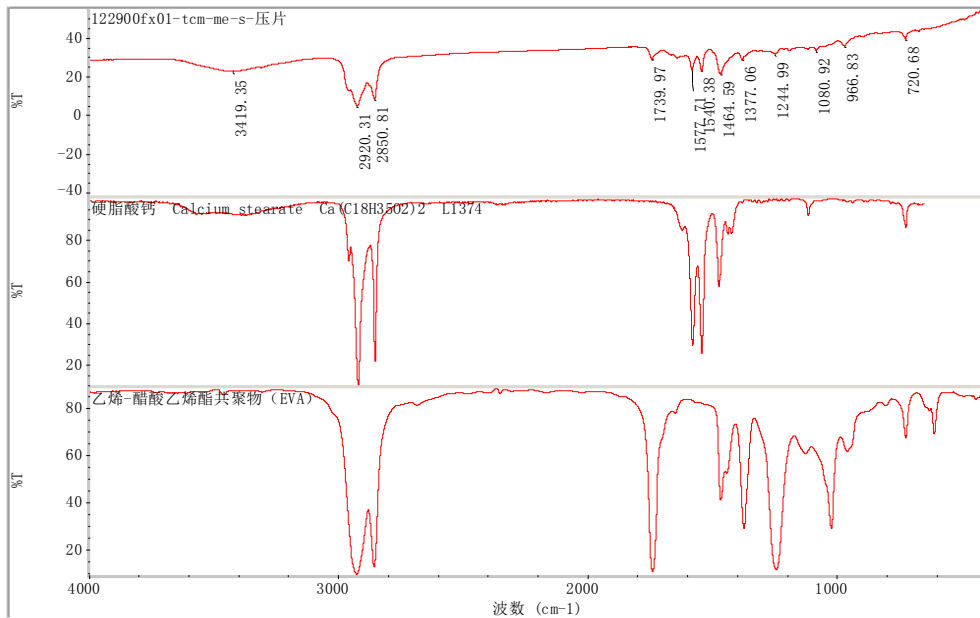


Fig. 1-6 Match FTIR

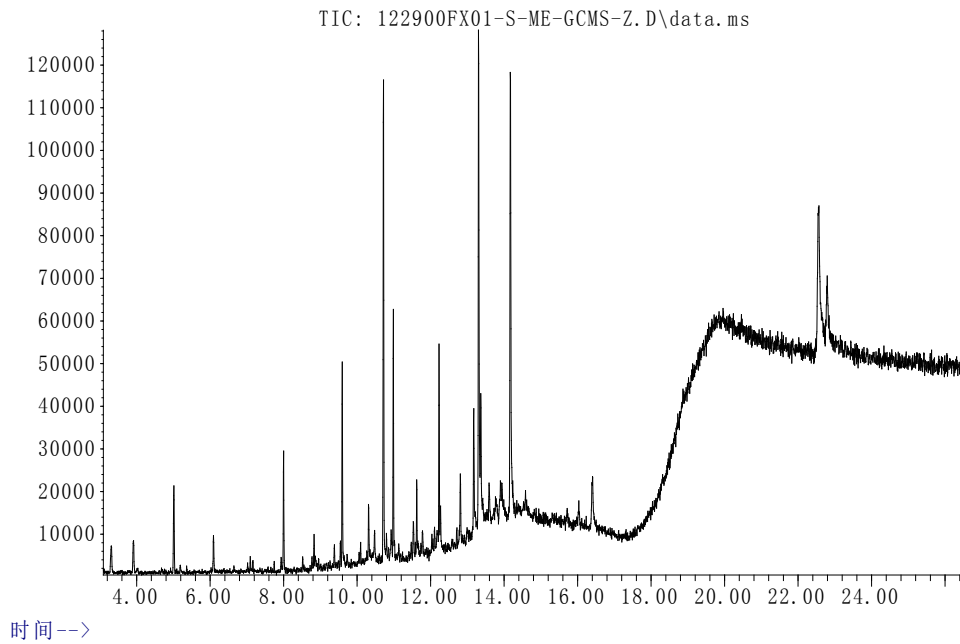

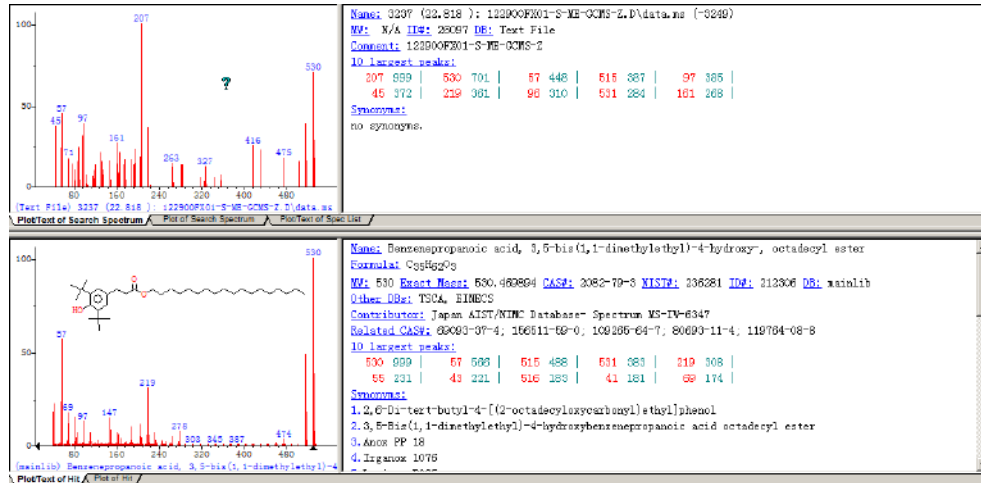

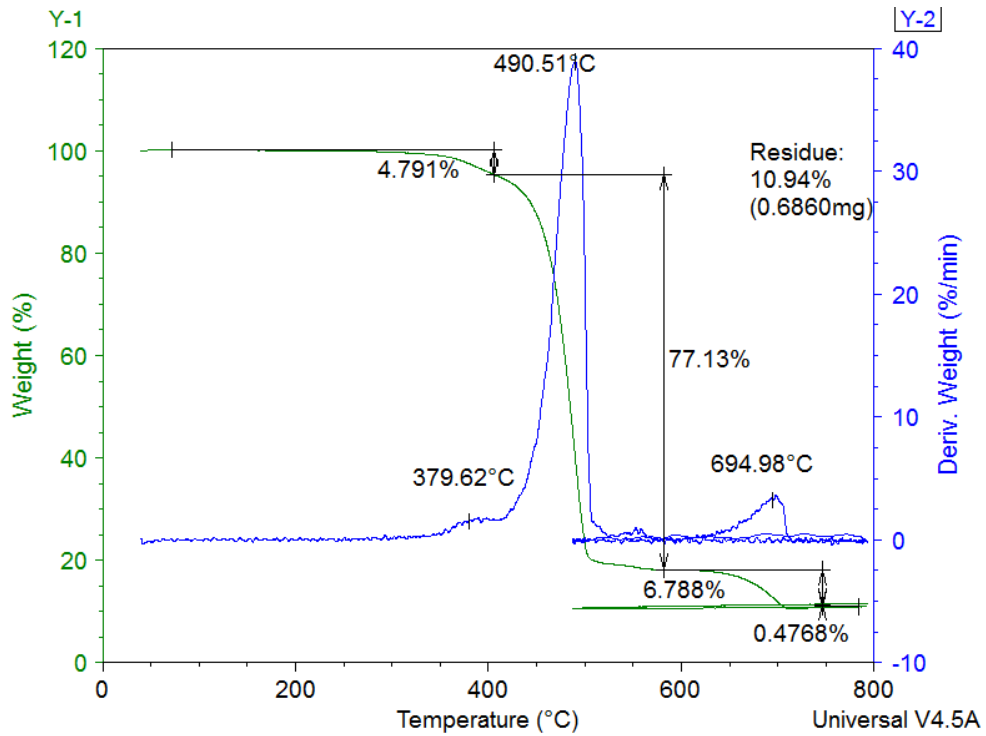


Fig.4 TGA curve of original sample

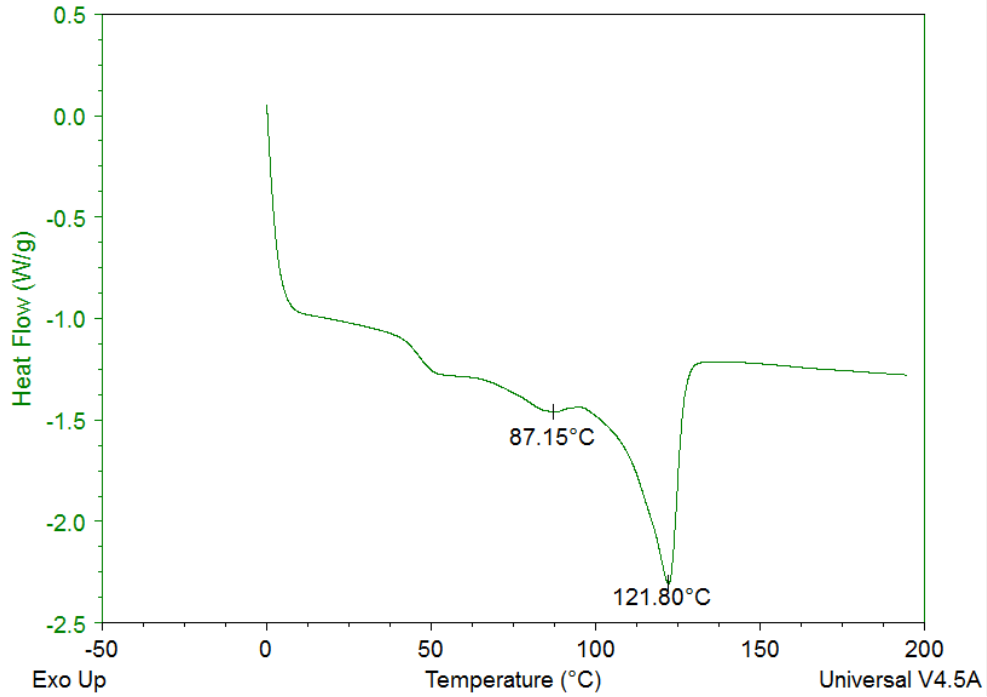


Fig.5 DSC curve of original sample
