(Hereinafter: the "Buyer")

Of the other part;

Whereas:

the Seller is a bus manufacturer; and

Whereas:

the Buyer wishes to buy buses from the Seller, and the Seller wishes to sell the buses to the Buyer, all under the terms and for the consideration set out in this agreement hereunder;

NOW THEREFORE, it has been declared, stipulated and agreed between the parties as follows:

1. PREAMBLE AND APPENDICES

- 1.1 The preamble to this agreement and the appendices attached hereto constitute an integral part of the agreement itself.
- 1.2 The section headings were solely intended for the convenience of the parties, and shall not serve for the interpretation of this agreement.

2. THE TRANSACTION

- 2.1 The Seller will sell to the Buyer, and the Buyer will purchase from the Seller 150 (one hundred and fifty) new Buses made by the Seller in accordance with the technical specifications of the bus, to be attached to this agreement as Appendix A (hereinafter: the "Buses").
- 2.2 Concurrent with this Agreement, and with each separate lot as described in article 3.2, the Buyer shall sign and dispatch to the Seller an order form attached to this Agreement as Appendix B. The filled-in order form will include a scheduled production completion date (hereinafter: "Production date"). The seller will convert the order form into an acknowledged order, within 7 working days of receipt of above order, and will acknowledge the Buyer accordingly.
- 2.3 The order form may include a list of additional equipment to be purchased separately, and to be installed in the buses per the final customer's requirements. The production date as described in the order form will apply here as well.

3. ORDER AND DELIVERY OF THE VEHICLES

- 3.1 In this agreement, the term "**Delivery**" refers to the date of acceptance of ready-for-delivery buses by the final customer, in Israel.
- 3.2 Delivery schedule is as follows:
 - 3.2.1 One hundred and ten (110) units to be delivered not later than 15 September 2018; these buses will be ordered by the buyer with the signing of this agreement.

- 3.2.2 Forty (40) additional units to be delivered, either in one lot or in parts, within six months of the buyer's order, and not later than 15 November 2019.
- 3.3 In the case of a delay in delivery regarding clause 3.2.1, and after 30 days grace (15/10/2017), the Seller will compensate the Buyer for the sum of 500 euros per day for each Bus.
- 3.4 Prior to the shipment of the buses to Israel, they will be inspected at the Seller's premises by the final customer. Shipment will take place only after a written approval of the buses by the final customer and the Buyers' representatives. This approval form is attached to this agreement as Appendix C.
- 3.5 First bus will be produced within 4 months after signing the Agreement. The first bus shall be inspected and approved in a written form at the Seller's premises by the final customer. In case changes from the technical specifications (Appendix A) are requested, AIOS keeps the right to postpone the delivery term and no penalty for delay shall be applied.
 - In case of non-compliance to the technical specifications (Appendix A), which will be determined by an independent expert (Laboratory of Ariel University), the delivery term will not be postponed and Buyer will be entitled to penalty for delay as stated in this agreement.
- 3.6 Inspection of the buses will take place within 14 working days of a written notice of the Seller to the Buyer, confirming the buses are ready for inspection. The quantity of the inspected buses will not be lower than 35 units at a time.
- 3.7 The duration of the inspection will not exceed six working days, for 35 units. The parties will coordinate and work together in order to meet this time frame.

4. CONSIDERATION AND TERMS OF PAYMENT

- 4.1 The Buyer shall pay the Seller for each Bus, produced according to **Appendix A**, a sum of 123,900 euro, EXW Kocaeli. This payment will include a five-year full warranty coverage as defined in the After Sale Agreement signed by the parties in 2012.
- 4.2 The additional list of equipment, as referred to in article 2.3, will be paid in addition to this sum.
- 4.3 Terms of payment:
 - 4.3.1 Within 30 days of order placement 24,000 euro per unit ordered
 - 4.3.2 The remainder shall be paid within seven days of the acceptance in Israel, by the Buyer, of a complete set of original shipping documents, to include at least the following documents: bill of lading, shipping list, eur.1 certificate and the invoice/s.
 - For the open balance between the consideration for Shipment and the Turkish EXIM bank limit, will be paid by the Buyer on a cash basis against documents of shipment.
 - 4.3.3 In case of a delay in delivery, the remainder sum (per article 4.3.2) will be offset according to the mechanism described in article 3.3.

5. FEES AND SURCHARGES

The two parties to this agreement will each bear its costs and financial expenses at their respective ends.

6. Fundamental Breach

Each of the cases listed below constitutes a fundamental breach of the Agreement, which confers upon the complying party, as the case may be, the right to cancel this Agreement immediately:

- 6.1 The Buyer has not made any of the payments that it is required to make under this Agreement within 21 business days from the day on which it received notice that it has not made the payment on the due date.
- 6.2 The Seller did not supply the Buses according to the technical specifications.
- 6.3 The Seller's accumulated delay in delivering the buses (that is, the multiplication of bus units by delay days) exceeds 1,000 unit*days.
- 6.4 The Buyer is in breach of another of the terms of the Agreement and has failed to rectify such breach within 21 days from the date on which written notice to this effect is given to the Buyer by the Seller.
- 6.5 The Seller is in breach of any of the terms of this Agreement, and the breach shall not be rectified within 21 days of the day on which written notice is given to this effect to the Seller by the Buyer.
- 6.6 In the event that the Seller and/or the Buyer cancels this Agreement due to a fundamental breach by the other party, the party in breach shall indemnify the injured party, upon its demand, for all costs and/or expenses and/or damages the injured party shall incur as a result of the breach and cancellation.

7. CERTIFICATION BY ATTORNEY/CPA

Upon signing this Agreement, the parties shall furnish each other with a certificate signed by their attorney and/or their certified public accountant (CPA), confirming that the signatories on their behalf are authorized to bind them under the terms of this Agreement.

8. <u>DEVIATION OR WAIVER</u>

The consent of either party to deviate from the terms of this Agreement in a particular case or a series of cases shall not constitute a precedent and shall not set an example in another case in the future.

Where a party has not exercised and/or has delayed exercising any of the rights conferred upon it under this Agreement, this shall not be deemed a waiver of any of its rights.

To dispel any doubt, the parties agree that no modification of the terms of the Agreement or a waiver of the rights of either party shall be valid unless made in writing and signed by the parties.

9. PRIOR AGREEMENTS

This Agreement fully expresses everything agreed by and between the parties regarding the matters discussed therein and it replaces and cancels any representations, undertakings and agreements that existed, if at all, between the parties in said matters prior to the signing thereof. No modification in the provisions of this Agreement shall be valid unless a written document was drawn up and signed by the Seller and the Buyer. In case that a non determined subjects in this agreement, AIOS-UTI Distributorship Agreement dated on 21/02/2012 shall be valid for the parties. In case of contradiction between this agreement and the distribution agreement, the provisions of this agreement will prevail.

10. JURISDICTION

UNIVERSAL TRUCKS ISPAEL LTD.

All disputes arising out of or in connection with the contract shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce (ICC) by three arbitrators appointed under

the same rules of Arbitration, in Paris, France. Law of Switzerland shall be govern substance of the dispute. Arbitration decision shall be definite and binding upon the parties.

11. Notices

Notices for the purpose of this Agreement shall be delivered by hand or sent by registered mail according to the addresses of the parties specified in this Agreement (or any other address to which appropriate written notice shall be given); and any notice delivered or sent as aforesaid shall be deemed to have been received by the addressee on whichever of the following dates is earlier: Upon its actual delivery at the address of the addressee and/or its offer for delivery at said address, in case of refusal to accept it, or after five business days from the date it was delivered for dispatch by registered mail or upon its transmission by facsimile according to confirmation from the fax machine and if by Email delivery – on the date of transmitting the notice.

12. Force Majeure

The Parties to the Contract are released from responsibility (except payment) for partial or complete non-fulfillment of their liabilities under the present Contract, if this non-fulfillment was caused by the circumstances of Force Majeure, namely: flood, fire, earthquake, war, civil war, strikes and lockouts. In this case the time of fulfillment of the Contract obligations is extended for the period equal to that during which such circumstances last.

13. Confidentiality

The Parties agree and confirms that the possession of all technical, financial, legal and commercial information whether or not legally protected, of which all provided by either Party, are belong to the Party delivering the information and under the scope of this agreement the Parties are obliged to protect Parties property right and keep the said information as confidential.

If a Party violates his obligations in part or in full that are set out in this clause, he accept and undertakes to indemnify the other Party for any loss including cost and expenses it has or will incur thereby, without prejudice the offended Party's termination right.

The Parties agree and undertakes this obligation and Parties right under this clause are for indefinite term
