In case the Buyer cancels the order after advance payment is made, the advance shall not be refunded and the Seller reserves the right to claim compensation for damages.

If the Seller fails to deliver the goods within the agreed 15 business days without justified reason, the Buyer has the right to terminate the contract and request the return of any advance payment.
