General conditions of Sale and Warranty

Origin of the goods:	EU, USA or Canada, unless otherwise stated
Payment:	Upfront payment or Irrevocable and Confirmed at sight L/C. Confirmation will be required at Buyer's charge on a First Class Bank.
Banking charges:	All banking charges are at Buyer's charge
Legalization fees:	All legalization fees are at Buyer's charge
Inspections:	All costs related to third parties inspections of the goods are at the Buyer's charge. Inspection, if any, shall be notified together with the order.
Delivery terms:	Ex-works
Pricing:	Prices are to be considered ex-works Buccinasco (Italy).
Packing:	Not included. Packing costs will be quoted separately to the Buyer.
Shipment:	Shipment will be made at the Buyer's charge and according to the Buyer's instructions. If the Buyer doesn't specify a forwarder, Villa Sistemi Medicali will choose its forwarding agent. Upon arrival at the first destination, products must be checked immediately by the Buyer for damage in transit. Encountered defects or damages must be reported in writing to Villa Sistemi Medicali within and not later than ten days after their arrival. Reports arriving after the expiry of the said period shall not be accepted for claims against transport damages or defects.
Delivery:	If not otherwise agreed, standard delivery time is 60 calendar days from receipt of payment or L/C confirmation; Villa Sistemi Medicali is not liable for delay in shipment, due to circumstances beyond its control, such for example, but not limited to, strikes, calamities, catastrophes etc. Ordered goods must be collected by the buyer within 15 days after notice that goods are ready for shipment has been given.
Insurance:	Shipment, storage, and delivery of goods are for the account and at risk of the Buyer. Benefits and risks are passed on to the Buyer upon hand-over of the goods to the forwarding agent.
Order cancellation:	If the Buyer cancels an order or part of an order, Villa may, at its sole discretion, invoice the Buyer and the Buyer shall pay to Villa, as damages, an amount equal to fifteen percent (15%) of the net selling price of the canceled portion of such order. Modification of a firm order may result in a reconfiguration cost to be estimated on a case-by-case basis.
Restocking fee:	In the event that Villa authorizes buyer to return products in new condition for credit and restocking, Villa may, at Villa's sole discretion, apply a charge equal to fifteen percent (15%) of the net sales price of any such returned products. All such authorized returns are to be shipped prepaid at buyer's expense and responsibility, to Villa's factory in Buccinasco, Italy.
Installation:	Not included; if installation is required by Villa Sistemi Medicali personnel, a quotation can be requested at the current Villa Sistemi Medicali Service Price List.
Training Classes:	To guarantee proper installation and after-sales support to end users, it is considered mandatory for the Buyer to attend technical training courses from the Villa Sistemi Medicali Technical Service Department. A Training Course Calendar is issued annually and can be requested by the Buyer at any time.
Warranty:	The warranty covers all parts against faulty material, design, and manufacturing defects that have been verified and accepted by Villa Sistemi Medicali. The standard warranty period is: For Medical X-ray tubes and Image Intensifier tubes: 12 months pro-rata for all parts from the date of installation but not more than 15 months from the issue date of the Villa Export invoice. For all other products: 12 months from the date of installation but not more than 15 months from the issue date of the Villa Export invoice. Costs related to troubleshooting, removal of defective parts, and replacement of repaired parts at the installation site are not included in this warranty. Defective items shall be returned to the factory for inspection. Freight charges and transportation risks for the return of defective parts and shipments of replacement parts are the responsibility of the Buyer. Villa Sistemi Medicali is not liable for damages due to normal wear and tear, lack of maintenance, failure to follow specific installation instructions, inappropriate operation, replacement of non-original spare parts, or for other reasons beyond its responsibility or control. In the event of defects in material, design, or manufacturing, Villa Sistemi Medicali is liable exclusively for the repair or replacement of the faulty goods, or – at its sole discretion – for credit of the value of the goods. Return shipments can take place only after authorization by Villa Sistemi Medicali, who shall issue an appropriate RGA (Return of Goods Authorization) with the relevant number. Villa Sistemi Medicali requires a complete warranty report describing the defects and relative operating conditions in detail, before return. Goods must be returned to Villa Sistemi Medicali in original or otherwise appropriate packing. Parts repaired under warranty carry the same warranty as the original system.
Traceability:	To guarantee the traceability, of installed products, according to EEC Directive MDD93/42, the Buyer commits to maintain a Customer Archive containing the following information: model and serial number of the products; name, address, and phone number of the installation site; name of the reference person at the installation site; installation and maintenance reports. The Buyer commits to provide such information to Villa Sistemi Medicali upon request.
