

LETTER OF AUTHORIZATION

June 5, 2020

To Whom It May Concern:

This letter will certify that Penumbra Europe GmbH, a corporation organized under the laws of Germany (“**Penumbra GmbH**”) and a wholly-owned subsidiary of Penumbra, Inc., a corporation organized under the laws of the State of Delaware, USA (“**Penumbra USA**”) and, together with Penumbra GmbH, “**Penumbra**”), has appointed FCPC “DataControl” SRL, an organization existing under the laws of Moldova (“**Distributor**”), having an address of 17/6, N. Testemitanu str., Chisinau, Moldova 2025, to serve as its limited exclusive distributor in Moldova (the “Territory”) for the Penumbra Products listed in the current Penumbra Product Catalog, and for associated parts and accessories (collectively, the “**Products**”). The Products are manufactured by Penumbra USA.

For the term of this appointment, this Distributor will be authorized to (1) import Products into the Territory; (2) sell, distribute, promote, and support the Products within the Territory; (3) offer the Products to public and private institutions in the Territory; (4) take appropriate actions to obtain, modify, and maintain registrations of the Products with regulatory authorities of the Territory; and (5), with Penumbra GmbH’s prior written consent, appoint Sub-Distributors authorized to take the actions described in clauses (1), (2) and (3).

Any Products obtained from third parties other than this Distributor or authorized Sub-Distributors are not authorized by Penumbra GmbH within the Territory and may exempt or invalidate any warranty, sales support or other benefits. You should contact Penumbra’s legal department immediately to report any marketing by such companies.

The appointment is for a term expiring **June 30, 2021**, but is subject to: (i) earlier termination without notice to third parties; and (ii) agreement to extend the terms of the appointment. For parties wishing to rely on this letter, Penumbra GmbH will endeavor to respond promptly to requests for confirmation that the appointment described in this letter remains in effect.


