Salt which has been added with potassium iodide, potassium iodate or other derivative iodinated. Particle size: between 0.125 and 0.6mm (> 90% of the product).

INGREDIENTS Iodated salt from Indonesia (Iodine: 6mg / 100g) and Anti-caking agent: E-535 (<1 mg / 100g).
