We have been informed that **S.R.L. PACIFIC MOTORS** (hereinafter called "the Applicant") will submit to the Beneficiary its Tender (hereinafter called "the Tender") for the execution of „ **The procurement of two 4x4 vehicles with enhanced traction with in the Project ROMD00024 (CTRAINED) Cross border joint training**” under Request for Tenders No. ocds-b3wdp1-MD-1773413971373 from 06.04.2026.

Furthermore, we understand that, according to the Beneficiary’s conditions, Tenders must be supported by a Tender guarantee.

At the request of the Applicant, we, as Guarantor, hereby irrevocably undertake to pay the Beneficiary any sum or sums not exceeding in total an amount of **33 408,08 MDL** (**Thirty-three thousand four hundred eight ,08 MDL**) upon receipt by us of the Beneficiary’s complying demand, supported by the Beneficiary’s statement, whether in the demand itself or a separate signed document accompanying or identifying the demand, stating that either the Applicant:

- (a) has withdrawn its Tender prior to the Tender validity expiry date set forth in the Applicant’s Letter of Tender, or any extended date provided by the Applicant; or
- (b) having been notified of the acceptance of its Tender by the Beneficiary prior to the expiry date of the Tender validity or any extension thereto provided by the Applicant, the Applicant has failed to (i) sign the contract agreement, or (ii) furnish the Performance Security and, if required, the Environmental and Social (ES) Performance Security, in accordance with the Instructions to Tenderers (“ITT”) of the Beneficiary’s Tender document.

This guarantee will expire, in any case on May 05, 2026 or earlier:

- (a) if the Applicant is the successful Tenderer, upon our receipt of copies of the contract agreement signed by the Applicant and the Performance Security, issued to the Beneficiary in relation to such contract agreement; or
- (b) if the Applicant is not the successful Tenderer, upon the earlier of
 - (i) our receipt of a copy of the Beneficiary’s notification to the Applicant of the results of the Tender process accompanied by the letter of the Beneficiary by which the Guarantor is released from all the obligations arising from this guarantee.

Consequently, any demand for payment under this guarantee must be received by us at the office indicated above, no later than the **May 05, 2026, inclusively**.

This Guarantee is Subject to the Provisions of the Civil Code of the Republic of Moldova.
